- > First Day Scholars were Mary and Alex McDowell, Leonie and Myrtle Foreman, Joy and Faith Baigent, Darey and Nola Griffiths, Alan, Harold, Ron and Keith Sharland
- > After two years Pig Hunters who were allowed to live in the school during the weekend burnt the school down

- An empty two roomed cottage was converted to a school by removing an inside wall
- ➤ The second teacher was Mr. Roberts and he had to make many a manoeuvre to maintain the school's average attendance
- > About 1936 Baigents stopped milling and the school closed down

18th February 1908 The new settlement in the Ronga is to be known as "Carluke," a town of that name in Scotland having been the birthplace of Mr. W. Brownlee, to whose energy and enterprise the settlement owes its existence. The original Carluke is a town in Lanarkshire, within five miles of the county town of Lanark, and about 20 miles south of Glasgow. The town is the centre of a thriving fruit-growing district, and has a large preserve factory. In the neighborhood are coal and iron, mines and engineering works; and it has a population of 5000. Other natives of Carluke now resident in this district are Messrs. Robert Forrest, David Young, and James Wilson

10th March 1908 CARLUKE SCHOOL.

TO THE EDITOR.

SIR,— Could you kindly inform the residents of Carluke why the Education Board do not move in the matter of getting the contractor to complete the Carluke School? It was supposed to be opened by the beginning of this year, but it still remains uncompleted. There are about forty children attending the present schoolroom, which is totally unfit for a third of that number. The Board boast of the well-ventilated schools in their district: Well, I only wish they would take a trip to Carluke and hold one of their monthly meetings in the room at present used as a schoolroom. This room measures 23 foot x 11 foot 6 inches, with 8 foot stud, two windows (of which only the bottom sash opens), and one door. Do you think it is right that parents should be compelled to send their children to a dungeon like this and have doctors' bills to pay, besides ruining the child's health? Hoping the Education Board will move in the matter. —I am, etc., Interested.

17th April 1908 Marlborough Education Board: Carluke.—A suggestion to change the name of Rimu Gully to Carluke was agreed to.—The appointment of a teacher was left 1 over for the incoming Committee to deal with.

14th May 1908 A certificated teacher is wanted .for the Carluke School. Particulars are advertised to-day.

5th June 1908 Carluke's Progress,— A couple of years ago the present site of Carluke township, in the Ronga, was mostly dead trees and stumps, unless one excepts a blacksmith's shop, where the horses used in the bush used to be shod. Today the township boasts of thirty or forty neat cottages, a school, a large boarding-house, a splendid band-saw mill, and a general store. The last named evidence of progress has been established by Mr. Orsman, of Havelock, and was opened on Monday last with a good all-round stock. We learn that Messrs. Brownlee and Co. also intend opening an upto-date branch of their Havelock business in a few weeks' time

14th July 1908 Mr. Parker moved that a tank be sent to Carluke and another one to Blind River if available

14th August 1908 Mr. Foley's appointment to Carluke was approved

25th August 1908 A most enjoyable social and dance was tendered to Miss E. Storey, who is leaving the Carluke school, by the children and their parents, in the new store now being erected in Carluke, kindly lent by Mr. A. Reade. During the evening a presentation was made to Miss Storey of a silver watch and chain given by the scholars and parents of Carluke. Mr. G. Kearny made the presentation, and spoke feelingly of Miss Storey's good work during the twelve months she was here. Despite the bad weather there was a large attendance. Messrs. M. Bourke and A. Laurence (accordion), and Mr. G. Brown (piano), were the musicians. W. Simpson was M.C. After the presentation Mr. J. Lambert responded on behalf of Miss Storey, and Mrs. Leonard made a few remarks in reference to Miss Storey's good work during her stay here. During the small hours supper was handed round, and later on people wended their way home in the pouring rain. The children occupied the floor till ten o'clock and then the adults.

2nd October 1908 The dominion medals were distributed to the schoolchildren on Saturday, 26th September. Some prizes were also given. The little people rushed home when dismissed, and related to their parents the words of encouragement and advice which Mr. Kearney, Chairman of the School Committee, had spoken to them. They exhibited the medals and prizes with much satisfaction, and the parents rejoiced in their joy

12th January 1909 PICNIC AT CARLUKE.

('Contributed). The Carluke School picnic and sports were held in Mr. C. Turner's paddock, and were a great success. The weather was all that could be desired, and people came from all parts of the valley, also from Nelson, Havelock, and Canvastown. The Committee had prepared a very nice programme and the children enjoyed it immensely. The chief events of the day were

Numerous other races were run during the day by the younger children, each child getting a prize. Mr. A. Wadey had a "curiosity" that caused great amusement. The ladies provided plenty of good ,things to eat.

In the evening a dance took place and was largely attended. Mr. G. Brown played first-class music, the piano being kindly lent by Mrs. G Brown, and Mr. T. Walker's violin playing was also greatly enjoyed. Mr. A. P, Wickins, who acted as secretary to the Sports Committee, deserves hearty praise.

16th March 1909 The name of Mr. H. Foley, B.A., Carluke School, has appeared in the list of successful candidates for the B certificate at the Teachers' Examinations, 1909. This is the highest examination which can be taken under the Education Department. We congratulate Mr. Foley on his success. If we do not mistake he is the only teacher holding this certificate in the Marlborough District at present, but no doubt his example will be quickly followed by some of the clever men engaged in the noble occupation of training the men and women of the future.

5th April 1909 The football match which was to have taken place on Saturday afternoon at Brownlee Park between the boys of Carluke School and Havelock School was unavoidably postponed, owing to the men who wore going to bring the visitors into Havelock upon the "oilpot" (*Oil Pot*) having to work in the afternoon. Nevertheless, our boys are looking forward to meeting them at an early date

4th May 1909 The term of office of the first school committee in Carluke came to an end on Monday, and an election of new members took place. Three of the former committee —Messrs. Keaney, Russell, and Leonard—would not consent to be nominated again, but Messrs. Pope and Butterworth were elected for a second year. Mr. H. Pope is chairman for the year 1909-1910, and Mr. J. Lambert secretary. The other members are Messrs. W. Mears, W. Simpson, D, Gould, and A. Pope. The members of the retiring committee deserve commendation for their regular attendance at the meetings, and for the absence of all bickering or disunion when they met. The chairman, Mr. Keaney, and the secretary, Mr. Russell, showed much tact and sound commonsense in the discharge of their duties. They gave money prizes to the children for good attendance, and contributed freely towards the school picnics and games. Among the works done during the year were the fencing of the

school ground, the building of a shelter shed, providing fuel for last year and this year, partial clearing of a playground, and providing for cleaning and repairs of the school. The committee carried on their work steadily, without friction with the parents, teacher, or Education Board, and never neglected the interests of children. The new committee will, it is confidently believed, be equally efficient when they settle to business.

The young ladies of Carluke intend to form a Hockey Club if they can enrol a sufficient number of members. They held a preliminary meeting on Saturday, 1st May, when they chose an appropriate Maori name, and selected Mr. Keaney as vice-president; he will probably find it more difficult to control those sprightly damsels than to direct the staid, serious members of the school committee, but he is just the man to undertake such duties with a light heart. —

11th May 1909 The Carluke Committee wrote recommending Miss Mary Scott for the position of assistant at their school.— Appointed

6th July 1909 Carluke.—Mr. J. Lambert, secretary of the Carluke School Committee, stated that the tank which was sent to Carluke from Havelock was in a bad state, and asked that the Board supply them with a corrugated iron tank. The letter also applied for more accommodation, as the present room was inadequate.—The Secretary of the Board was instructed to enquire where the second tank sent from Okaramio had gone to. With regard to the accommodation it was decided to inform the Committee that they should make application to the Government for a grant of £150 similar to the Seddon School Committee.

13th July 1909 Mr. J. A. Lambert, secretary of the Carluke School Committee, forwarded a plan and estimate of the proposed additions to the Carluke School.—Mr. Leonard also submitted a plan of the proposed addition to the Carluke School.—The Chairman said that too much money was being wasted by Education Boards, and he thought proper inquiries should be made into this school, so that the secretary would be able to satisfy the Government that the Board is not wasting any money. That suggestion was adopted

17th August 1909 The local school is to be visited by Mr. Strachan on Tuesday, and no doubt the day is being looked forward to with apprehension by pupils and teachers. Apparently the proposed addition to the school has been laid aside, as nothing more has been heard of it since it came up before the Education Board last month. Surely such a necessary improvement should meet the approval of those who have power to act

7th September 1909 The local school was examined a short time ago and the inspector's report was very favourable, Mr. Strachan having reported that he was very pleased with the progress that had been made," and also that there had been a great improvement in the school since his last visit a short time previously.

14th September 1909 PUMP GRANTED The Carluke School Committee forwarded an estimate of the cost of installing a pump at the school, which was £7. This amount was granted by the Board. It was also decided that the additions to the school be approved.

28th September 1909 The addition to the local school has been granted by the Education Department, and will soon be started. I omitted to mention in my former reports that one "proficiency" and two "competency" certificates were gained by

three pupils of the Carluke school at the examination held by Mr. Strachan, on 17th August.

12th October 1909 Some tenders were received for additions to the Carluke school, but were held over pending a reply from the Government with regard to a grant for the work

21st December 1909 The Carluke school-children gave a concert on Friday night. This concert was held to obtain funds for the spoils to be held here on New Year's Bay. The school closed down for the midsummer holidays on Friday. Mr. Foley (the head teacher) is remaining in Carluke, whilst Miss Scott (the assistant teacher) leaves on Monday for Invercargill. The Rai Valley school is to close down on Wednesday. Two pupils from Carluke and two from the-Rai Valley school sat for the sixth standard examination at Canvastown on Friday last. One pupil from each school passed.

30th December 1909 the central examination at Canvastown two candidates from the Carluke School presented themselves one of whom obtained a Proficiency certificate and the other a Competency certificate in the Sixth Standard. As Proficiency and a Competency were also obtained in August, this makes a total of two Proficiency and two Competency certificates in the Sixth Standard awarded to. the pupils of this school during the year 1909.

31st December 1909 SCHOOL CONCERT AT CARLUKE

(Contributed). On Friday, 17th December, Carluke School closed for the midsummer holidays. The headmaster, Mr. H. Foley, B.A., spoke a few words in which he wished the pupils a very satisfactory time during their period of absence from books and study. Master Fred Mears, the oldest boy in the school, responded by calling for a cheer for Mr. Foley, which was given with much heartiness and vigour. Cheers were also given for the assistant, Miss Scott, and Christmas cards were presented to the teachers by several pupils. The prizes for good attendance, etc., will be presented on New Year's Day, at the children's sports. Of the two pupils from the Carluke School who presented themselves at the central examination in Canvastown that day, Miss Rose Wickens obtained a proficiency certificate and Master Robert Mills a competency certificate. As Miss Jeanette Leonard obtained a proficiency certificate earlier in the year and Miss Wickens a competency certificate, this makes a total of two proficiency and two competency certificates for the school for the year 1909. 1 The prizes for best school gardens were presented to Masters Fred Mears, Albert Simpson, Roy Mears, and Robert Mills.

The children's concert on Friday night was a great success. This is chiefly due to the energy displayed by the members of the School Committee in the matter. Mr. H. Pope spared no pains in making the preliminary arrangements, while Mr. J. Lambert acted as chairman and Mr. W. Mears as doorkeeper. Over three pounds were collected. Mrs. Melville and Mr. Brown presided at the piano, and songs were sung by Messrs. Melville, Brown, and Thompson, which were much appreciated by the audience. Among the items given by the schoolchildren were a song, "Say, Schoolmates, have you seen Vacation?" by girls and boys dialogue, "Across the fields of Barley," by Ruby Beal and Lily Walker; recitation, "I'll do as Mother did," by Hilda Leonard; song, "When there's love at Home," by Lily Walker, Agnes Blanchett, Ruby Beal, and Hilda Leonard; recitation, "Hiccups," by Agnes Blanchett; recitation, "A Truthful Witness," by Hilda Leonard; song, "Drive the Nail," by six boys; dialogue by Fred Mears, Albert Simpson, Roy Mears, Bert Boyd, and Mervyn Scott; "Ten Little Niggers," by ten boys; dialogue by Arthur Pope and Walter Pope; dialogue by Fred Mears and Albert Simpson; recitation, "Dirty Jack," by Reta Leonard; "Action Song" by infants; recitation by Enid Scott; action recitation by infants; recitation by Vera Butterworth; song, "Isle of Beauty," by infants; song, "Christmas Time is coming," by infants. Mr. J, Lambert, secretary of the School Committee, expressed the pleasure all present had received from the performance of the children, and Mr. H. Pope, chairman of 1 the Committee, congratulated Mr. Foley on the successful carrying out of the programme, saying that it showed clearly how carefully the pupils had been prepared by their teachers. After the concert a dance was started, which was much enjoyed by those present, and Which was continued until midnight, when all retired to their homes feeling very pleased with the way in which they bad spent the evening.

21st January 1910 The name of Miss Jeanette Leonard, of Carluke, appears in the list of those who passed the Junior Civil Service examination. She was during the last year and a quarter a pupil of Carluke School, and trended at the Nelson Centre.' Since' the examination she has been appointed teacher of Cape Campbell School, under the Marlborough Board of Education.

3rd February 1910 Miss Scott, assistant teacher at. Carluke, has returned from her holiday at Invercargill

15th February 1910 The Marlborough Education Board yesterday granted the Carluke School Committee to use as they consider advisable nine acres of the school reserve. The chairman, Mr. Fulton, waited upon the Board and explained that they wanted to let the ground so as to raise some money with which to improve the playground

26th April 1910 The name of Mr. HI Foley, B.A., of Carluke, appears in the list of those admitted to-the ad eundem in the University of New Zealand at the meeting of the Senate in January.

29th April 1910 CARLUKE. The following gentlemen being the only householders present, and on their signifying their willingness to act, the chairman, Mr. Pope, declared them elected for the ensuing year. Mr. Pope was elected chairman and Mr. J. Lambert secretary:—Henry Pope, Arthur Boon, John Butterworth, William Mears, Alfred Pope, Frederick Scott, John A. Lambert

12th July 1910 A REQUEST REFUSED. / The Carluke School Committee applied for a grant of £4 for the purpose of rebuilding a defective chimney at the school. The Chairman said that he could not 'agree to this . request , being granted; and the Board; could not go back <m a previous resolution dealing with this matter. The letter was received, as the Board had decided not to go beyond £3

2nd August 1910 FOOTBALL.

SCHOOLBOYS' MATCH. A team of youngsters from the Carluke School visited Havelock on Saturday to try conclusions with the local School fifteen, and were defeated by 12 points to 8. The game was controlled by Mr. J. Campbell, who had no end of a task to convince some of the boys that he at least knew the difference between the goal-posts and the line umpires. It was a strenuous game at times, but several of the lads showed a rare turn of speed and not a little agility in dodging. For Havelock, Leslie Walker kicked a goal from the field and also scored a try, and Eric Buckman scored two tries. These were the beat individual players on the ground. Roy Mears scored two tries for Carluke, and played a pretty game; Pope kicked a goal from the second try. Others from the bush village who played well were "Kruger" Simpson, Mears, jun., and Pope. Alter the match the boys were entertained at the school by several ladies.

10th August 1910 The chairman of the Carluke Committee, wrote_advising the Board that Messrs. J. Lambert, A. Pope,- A. J. Brown, W Mears, J. Butterworth and H Pope had resigned their position as committeemen as a protest-against; the Board's action regarding

the chimney at the school; which was in a dangerous condition, and also on the ground of the unfair treatment meted out to it by' the Board. The resignation was accompanied by a financial statement Mr. Reader moved that the resignation be accepted, and that Mr. F. Scott be written to and asked to act as correspondent and to call another meeting of householders. Mr. White seconded the motion. Mr. Reader said that the Carluke Committee had received everything it had asked for. Mr. Storey said they had been well treated. ~ Mr. Strachan pointed out that the chimney was defective, and that at present it was propped up with sticks. The motion was carried. It was decided to haw the chimney pulled down and rebuilt

16th August 1910 The local school was examined by Mr. Strachan about a fortnight ago, and I hear that the teachers have nothing to complain of in regard to his report

6th September 1910 It must not be forgotten that a number of other . schools carry on* the education of pupils- beyond S. 6. During recent, years the Blenheim girls' school, Canvastown and. Carluke have all passed pupils through Civil Service Junior and. teachers' examinations.

14th March 1911 WATER WANTED. The chairman of the Carluke School Committee wrote pointing out that since the mid-summer holidays the pupils had had to endure much inconvenience owing to there, being an insufficient supply of water. He understood that Mr. McIsaac had power, according to an agreement, to turn off the water whenever he chose to do so. He asked if this were the case. In connection with this matter Mr. J. H. Lambert forwarded a copy of an agreement entered into by the Carluke School Committee with Mr. McIsaac,, which stated that Mr. McIsaac had power to use the water only for his own house, but that the Committee should not interfere with his water-supply. The Chairman, moved, and Mr. Reader seconded, that the Board provide a tank for the school; in the meantime the secretary to inquire, into the cause of the shortage of water.—Carried

23rd March 1911 The Education Board invite applications for the position of assistant teacher at Carluke

11th April 1911 Miss M; Kelleher applied for the position of assistant teacher at the Carluke school. 'Miss O. O. Jones also applied for this position. Inspector Strachan reported that Miss Jones was ineligible, and that Miss Kelleher, although having had a number of years' experience at le Awaite, had not a certificate. _ , It was decided to forward Miss Kelleher's application to the Carluke Committee

Miss Scott forwarded her resignation as assistant teacher at Carluke, which was accepted 9th May 1911 The Carluke Committee applied for a grant of £3 for firewood. • The Chairman moved, and Mr. White seconded, that an advance on the next quarter's subsidy be made.

10th June 1911 Two attempts to burn down schools have; recently been reported to the Education Department. One was in Southland., --The Board, owing to the movement "of population, had decided to remove a school for some distance, despite protests on the part of some of the parents concerned, and let a contract for the removal. While the worn: was, in progress the build was twice" discovered to be on fire, under: circumstances which pointed to incendiarism, but it was found impossible to fix the blame on anybody. - Another case was in Marlborough, at Carluke, on March 21st, arid occurred just before the children assembled for school The fire was right underneath the school, where the flooring was only a few inches from the ground. In this instance also no trace of the offender was discovered, although the police made a, searching inquiry into the matter. This was dealt with in committee by the Marlborough Education Board and the press was requested, to make no mention of the occurrence pending investigations.

15th August 1911 A CHIMNEY. The Carluke Committee applied for £1 for repairs to f the school chimney. This was referred to the secretary

14th November 1911 CARLUKE SCHOOL. The Carluke School Committee applied for a grant of £2 for painting outhouses and shelter shed, and a further grant of £1 for conveying the pupils in Standard V. to Canvastown -for the purposes of examination. The first application was granted. In reference to the second application a letter was read from the Committee re the conveyance of pupils to Canvastown for examination

2nd January 1912 A correspondent writes:—On Friday, December 10th, the annual distribution of prizes took: place in the Carluke school. The prizes were presented by the headmaster, owing to the unavoidable absence, of Mr. Pope, Chairman of the. School .Committee. When the prizes had been distributed hearty cheers were given foe Mr. Pope, the teachers, and the prize-winners. Miss Kelleher, the assistant, .set-out the same day for her home in" Blenheim, and a few days later Mr. H, Foley, B.A., the headmaster, proceeded to Auckland for the holidays

20th January 1912 FOLEY—JAMES.

At St. Patrick's Cathedral, Auckland-, on January 10th, a quiet wedding was celebrated, when Miss Anstice James, youngest daughter of Mr. R. James, of Auckland, was married to Mr. Hugh Foley, B.A., headmaster of Carluke School, Marlborough, youngest son of the late J. Foley, headmaster of Shragarn School, County Leitrim, Ireland. The ceremony was performed by the Rev. H. F. Holbrook. The bride, who was given away by her father, was attired in cream glace silk, trimmed with silk lace and pearl trimmings. He hoped that they would always bear in mind that they did not come to school to pass their standards only, but to be taught to become good citizens and good men and women-which he was sure they would all become. He emphasised the importance of more co-operation between parents and the teacher. A child may have a little peculiarity in its nature, and a little understanding between parent and teacher in such cases is very helpful. He was a believer in plenty of healthy sport and exercise, not only for children and growing men but for young women. He was afraid that in providing sport for young men the physical development of young women was often neglected. In .conclusion Mr. Reader suggested that a tablet be erected to commemorate the men who had left the district to serve their country. The tablet should be something substantial—to last for all time—and' should bear the names of all who served, with special distinction to those who have fallen. Mr. Reader's remarks were received with loud applause

Mr. Reader went to Dyer school in the Wellington Education Board area just south of Martinborough and by 1921 was back in Marlborough at Tua Marina School

MARLBOROUGH MOVE

SEVERAL SCHOOLS CLOSED

(By Telegraph.) (Special to the "Evening Post.")

BLENHEIM, This Day.

As a result of consultations between the Marlborough representatives on the Wellington Education Board and the parents of children attending several of the country schools in the district, the policy of consolidation introduced by the Minister of Education (the Hon. P. Fraser) is to be brought into effect in the Ward, Seddon, and Rai Valley districts.

In the Ward district two small schools have already been closed, the pupils being conveyed to the Ward School by motor-bus, and in the Seddon and Rai Valley districts several schools will be closed as from the beginning of the new school year. At Rai Valley the schools affected will be those at Opouri, Pelorus Bridge, Ronga, and Carluke. Pupils at present attending the schools mentioned will be conveyed to Rai Valley School by three separate bus services, one for Pelorus Bridge, one for Opouri, and one for Ronga and Carluke. The attendance roll of the Rai Valley School will thus increase from 37 to 122. The provision of extra accommodation at Rai Valley will be necessary, and a building programme will shortly be put into operation, the intention being to build along open-air lines as far as possible.

Taimate and Mirza Schools, in the Ward district, have already been closed. The pupils are being brought into the Ward School by two motor-bus services.

It is intended to adopt the consolidation policy to a further degree in one area in the Seddon district. Seaview, Marama, Blind River, Grassmere, and Tetley Brook Schools will be closed as from the beginning of the new school year. The attendance rolls at Ward and Seddon Schools will be increased from 86 to 111 and from 91 to 145 respectively. Education Board representatives commented that in a very great majority of cases parents appeared to agree with the Minister and the Wellington Education Board, which was strongly in favour of the scheme. The policy had been in operation in a number of districts in the North Island, and a start had also been made in Canterbury. This was the first occasion that anything of the kind had been attempted in Marlborough


Flat Creek (1912-1923)

- > The settlers in a petition agreed to find a site for the annual rental of £5, they would supply the timber and free labour but asked the Education Board to provide roofing iron, windows and sashes
- > The school was approved in 1917

- > The settlers cut the timber and had it milled to length and then left it to be seasoned
- > The site chosen was on Mr. Kerr's place between two swing bridges
- > The first teacher was Miss Margaret Burton of Redwoodtown.
- > She first boarded with Mr. T Wells but found crossing the first swing bridge made her giddy so she removed to Mr. and Mrs George Well's home
- The second bridge was OK she crossed the bridge 4 times a day. (Presumably she went home at lunch time.
- Miss Mary Rennal was considered to be the last teacher of Kaiuma School
- > There was agitation for another school on the Education Reserve The settlers argued that the current school was only a makeshift school and a new school should be established on the Education Reserve 3 miles further up the valley

There was no doubt the original site for the new school was the proper one. —It was decided to fall in with the wishes of Mr Russell and the settlers

13th August 1907 RIMU GULLY. The Department intimated that a grant was available for the proposed new school at Rimu Gully. Mr Reader said they would need before long to accommodate forty children. He said he understood Miss Storey had been recommended for the teachership, and would be pleased to move that she be appointed. It was resolved that a separate school district be gazetted; that the Government be thanked for the grant that the Committee suggested be appointed; that the residents be asked to submit a plan; and that the site furthest from Flat Creek school be chosen definitely.

15th October 1907 Havelock. —Mr Reid, contractor for twelve school-desks, asked where to send them.—Mr Storey reported having inspected the desks. Undated Newspaper cutting included the following information on the Rimu Gully School supplied by Linden Armstrong, Havelock Museum

- > Early in March 1907 a move was made to start a school at Rimu Gully. Brownlee's had increased their payroll and more families had arrived
- > At an informal meeting it was announced that one if Brownlee's storage shed would become available and this could be used as a classroom.
- As soon as this became public the Flat Creek (Rai Valley) School Committee became upset
- > Letters to the land Board and Marlborough Education Board pointing out there was no need for a second school were written
- At a meeting it was announced that not one Flat Creek child would be taken for a new school
- > 9th July 1907 Mr. Russell conducted the Board asking for a teacher to be appointed as they could rent a suitable house for a school
- ➤ Settlers were asked for a plan for a new school on Section 32 Block 1 of the Wakamarina Survey District
- ➤ Mr. J A Lambert prepared plans and contracted to build it for £140. Accommodation was provided for 54 children Mr. Lambert would provide desks at 25 shillings each (There was 20 shillings in a pound)
- > September 9th a new school district was formed for Rimu Valley
- Marlborough Education Board agree to start school in one of Brownlee's four roomed houses. This house was in the area called the Back Alley, overlooking the Carluke Domain
- ➤ The first teacher was Mrs Jack Doyle. Maiden name Elsie Storey, She had recently been relieving at Tua Marina . In July she travelled by Newman's Bus and took up living with Mrs Jack Scott. She was allocated £1 travelling money
- > January 13th 1908 The School Committee reported the new school will soon be finished
- ➤ The Board told the School Committee that Miss Storey's appointment was temporary and when finished the Board would appoint a male teacher
- > The School Committee expected 40 students on opening and wanted a male certificated teacher
- > 13th April 1908 the building was finished at a cost of £175. The Board also wanted to put a ring fence around to keep out wandering cattle
- > The school started with a roll of 24

- > It was not until August that the Education Board found a Male Teacher to replace Miss Storey. Mr. Hugh Foley M A was an Irishman.

14th May Land Board W. H. Turner applied, to lease the eight acres of land north of the school site in the Ronga Valley (Block 1., Wakamarina S.D.), and adjoining the portion leased to D. Young, and offered to clear the scrub and blackberries and lay the land down in grass.—It was resolved that a. year-to year lease at the pleasure of the Board be granted, on condition that the noxious weeds were kept down, the rental to be 2 shillings per acre.

17th March 1914, An extension of time for a month was given, Education Board (*For what*) 16th April 1914 RONGA VALLEY. Messrs C. Nees, J. Storey, presented, a report on their visit to the Ronga Valley. They recommended the Board to secure a piece of land at the top corner of Mr B. Hughes's section and erect thereon a school to accommodate 36 children. They also suggested that the .Ronga Valley watershed be declared a new and separate school district. It was, resolved that steps be taken for the acquisition of a suitable site and that a report be presented at the next meeting.-

BLENHEIM, This Day.

As a result of consultations between the Marlborough representatives on the Wellington Education Board and the parents of children attending several of the country schools in the district, the policy of consolidation introduced by the Minister of Education (the Hon. P. Fraser) is to be brought into effect in the Ward, Seddon, and Rai Valley districts.

In the Ward district two small schools have already been closed, the pupils being conveyed to the Ward School by motor-bus, and in the Seddon and Rai Valley districts several schools will be closed as from the beginning of the new school year. At Rai Valley the schools affected will be those at Opouri, Pelorus Bridge, Ronga, and Carluke. Pupils at present attending the schools mentioned will be conveyed to Rai Valley School by three separate bus services, one for Pelorus Bridge, one for Opouri, and one for Ronga and Carluke. The attendance roll of the Rai Valley School will thus increase from 37 to 122. The provision of extra accommodation at Rai Valley will be necessary, and a building programme will shortly be put into operation, the intention being to build along open-air lines as far as possible.

Undated Newspaper cutting included the following information on the Ronga School supplied by Linden Armstrong Havelock Museum

- ➤ Between 1907 and 1910 Mr. W H Turner conducted a governess school in his own house and for his own family. The Governess was Miss King
- > In April 1911 a land ballot was held but some farmers did not take up their land
- > This history was compiled from the memories of Rudolf Lafrentz a settler in the area
- > Most of the children were so shy that they took to the bush when strangers came by
- Mr. A J Hewetson erected a large board table under a lace-bark tree and five days a week conducted a school
- > My brother William and I were invited to attend the school
- ➤ On arrival the school table consisted of William and "son" Lafrentz, Rona, Len and Stan Hewetson, Nessie Haswell, Toby and Ken Pope and "Sandy" Boyd
- > Vera Hewetson could handle boys. She did not strap but threatened to call in her father the Manager of the sawmill
- > The first school built by the Education Board in 1912 consisted on one room, a storage shed and school conveniences
- ➤ Miss Kathleen Woulfe was the first appointed teacher (Not Correct) She was a lively read headed and well informed mistress. She came from Mirza School
- > The opening day roll was 15 in 1915 Miss Woulfe went to Korimako School
- ➤ The next teacher was Mr. Stratford where he introduced; rounders, tip cat, prisoner's base, cricket and football of a sort
- > The school burnt down and we were taught in Mr. Bert Hughes's Whare below the old school site
- ightharpoonup By October a new site had been selected and levelled. Mr. A G Mills built the school at a price of £229/1/0
- > The building consisted of a classroom 15 foot x 14 foot, with a porch of 8 foot by 6 foot and a shelter shed 8 foot x 6 foot
- > Mr. C F Stratford was Teacher and Miss Hewetson was sewing mistress
- > In 1918 Mr. Sturrock School Inspector reported that Mill's School had been destroyed by fire
- ➤ The school teacher was without board and lodgings and there was no chance of getting a room open for opening day February 1920
- > The Carluke School was 7 miles away from the Ronga School and the roads during winter were simply atrocious.
- > Tenders wer called and closed on February 6th 1919. The tender of Mr. Thompson of £365 was accepted
- ➤ May 29th 1944 Messrs. Harry Duckworth and Stan Hyndman (Board Members) reported "Found School in a state of disrepair and neglect. Very rotten in parts. Recommend sound timber and sheets of iron be saved the balance to be sold and the school site

13th September 1912 RONGA. VALLEY. Mr. W. Aitken Russell, of Himitangi, Rai Valley, wrote in behalf of two settlers, asking that an aided school be established in the Ronga Valley. It was desired to make provision for seven children. Mr. Turner was willing to provide the necessary accommodation for the - school and teacher

18th October 1912 Mr. Nees presented a report on his investigation of the conditions at the Ronga Valley. He recommended that the aided school be established at Mr. Turner's place. He was convinced that, in view of the progress of settlement, a State school would require to be established at that locality in the near future.—The recommendation was adopted

7th February 1913 Miss King returned to the Ronga School last Friday,

18th May 1914 Arrangements were made for the clearance of the new school site at Ronga Valley at an expenditure not exceeding £10

12th June 1914 RONGA VALLEY

A letter from the correspondent having been read, it was resolved to reply that, as soon as the question of the site had been settled, the Board would avail itself of the offer of the settlers in regard to the clearing and fencing of the ground preparatory to the erection of a school.

14th August 1914 On the recommendation of the committee, it was resolved that tenders be called for the stumping of the school ground at Ronga Valley, and that the work of fencing be held over in the meantime.

10th September 1915 Pelorus Road Board Ronga Valley settlers, wrote re the state of the roads. A few days ago the school was closed for three days, as the roads were in such a state that neither scholars or teacher could get to school; and on another occasion the children went to school in the morning and could not get home again owing to rivers and creeks rising.

Mrs. Ada Pope, Ronga Valley, wrote asking the Board to put a footbridge over the creek called Campbell's Creek, as school children—if the water is too deep to wade through—have to cross on a broken log, which is not safe.—The secretary was instructed to attend to these requirements

13th September 1918 Word was received yesterday morning that the Ronga public school had been totally destroyed, together with its contents, at half-past ten on the previous evening. The only person who appears to have seen the outbreak was Mr. Charles Pickering, who lives nearby. The teacher (Mr. Clarence Stratford) reported the occurrence to the Havelock police by telephone.

24th September 1918 Wellington Education Board held last Wednesday, the destruction of the Ronga Valley School by fire was reported by the secretary, and it was decided to obtain a report from the Ward members on the circumstances, when application will be made to the Department for reinstatement of the building

4th October 1918 An enquiry into the circumstances surrounding the burning of the Ronga public school was held on Wednesday at Ronga Valley by Messrs. B. McCallum, M.P., E. C. Penny, and J. C. Logan (the latter representing the Education Department), but no light was thrown on the origin of the fire.

- The first school was five miles from Pelorus Bridge school. It was built by mill workers
- Miss M Gibson was first teacher and opened the school in February 1921 with 12 pupils
- ➤ In 1923 Mr. D V Sutton took over and was there for 6 years
- ➤ Then came Mr. C M Lambert who stayed till 1933
- Mr. W J Scott stayed until 1936 when the school closed for a term and he was transferred.
- The second school was opened and taught by Mrs. M A R Bryant (Nee Miss M Gibson) she continued until it closed in 1938

Tinline

This article is a summary of Correspondence between Wellington Education Board and Tinline School on a number of topics but mainly re furniture. All articles below are in summary form.

The originals are found at Marlborough Archives

12th November 1923 Telegram to J C Logan Blenheim (Officer of Wellington Education Board for Marlborough with an office in Blenheim) From Education Board in Wellington Tinline Valley requires eight dual desks, one easel one blackboard chair and table. Desks could be procured from Havelock and Canvastown,. Arrange for supply

24th January 1924 Letter from Mr. F Gardiner Secretary Tinline Valley School Committee Included would you kindly send us some desks for our school and we would like to have the room more convenient for our teacher and children before school opened again for the New Year

We also would like some blackboards as the ones we are using are what has been left for us

18th February Letter from J C Logan Clerk of Works to Wellington Education Board included

I arranged for Mr. Williams who carts timber from Bryant's mill at Pelorus Bridge to pick up furniture from various schools but he didn't do it. Promises to do it on his way out today

13th March 1924 I am getting an easel and tables made at Carr's and they can be taken out by their motor lorry. It was not possible to get these items on route. This will complete the requirements of this school J C Logan Clerk of Works

19th March 1924 Telegram from Education Board to Mr. Logan Minister has telegraphed Department that no desks received Tinline School Please ascertain position immediately. Telegraph reply

19th March 1924 Telegram. Reply Tinline Mill Owners timber waggons (Sic) have repeatedly failed to convey desks from Canvastown suitable arrangements now made see my report on subject J C Logan

8th March 1927 Letter from A N Burns Inspector to Secretary Wellington Education Board

The school should be equipped with more modern desks- not necessarily new

The requirements are 5 large, 5 Medium, 3 small

The Medium and Small ones are urgently required as all the desks are large size and too large for little ones

If the desks are available in Blenheim the Committee if approached might arrange for them to be conveyed free by one of the timber trucks returning empty

Note Send instructions to supply from surplus desks if held in surplus at Blenheim

27th February 1929 Letter from D V Sutton T would like to know if Board can supply me with about 4 small desks for the primer classes The only desks here are suitable for Standard 3-6 only

It is almost impossible to teach the infants classes writing etc. In these desks as their feet are about 6 inches off the floor and the tops of the desks are too high for them

Note at bottom Supply can be obtained from Flat creek Teacher to make arrangements for delivery to school

Write Teacher Flat Creek requesting him to allow 4 small desks to go to Tinline. They will be replaced with infant table and chairs I(H Watson listed as Head of Flat Creek)

19th March 1929 letter to D V Sutton that Flat Creek head teacher will arrange to send desks to Tinline Valley

19th March 1929 Letter to Mr. H W Watson Flat Creek, telling him to do as above

11th July 1930 Letter from F Gardiner Secretary School Committee to Wellington Education Board included

- a) School Committee want to procure some new desks for Tinline School
- b) The current ones are very shaky old things, very rickety and we have not enough to seat all the children
- c) Also a new chair for the one we have is nearly falling to pieces and is only an ordinary kitchen chair
- d) We were under the impression that there were new chairs coming about 2 years ago but have not arrived yet
- e) Pencil note at Bottom Reply: The matter has been referred to the inspectors for their direction as to size etc.

18th July Letter sent from architect as above to Tinline School

1st August 1930 New letter saying matter has been deferred until the inspector has actually visited the school to assess size of desks

23rd October 1931 A M Roche letter to Wellington Education Board I have 20 desks in which to put 27 children so please send them soon

Pencil Note at bottom. Inventory shows 3 No 2 desks and 7 No 3 Desks. (This also often happened, but the Wellington Education Board was never wrong!!!!!)

27th October 1931 Telegram to Dr McIlwraith, Havelock Hotel (*Inspector*) Teacher Tinline Valley request extra desks. Kindly look into question furniture and advise

28th October 1931 G L McIlwraith's report included

Roll 27, Number of Desks 10. Of these 8 are largest dual type, 2 are two inches lower. All have the absurd arrangement of seat attached to front of the desk. Most are rickety

Five (5) modern desks are available at Pelorus Bridge. Tua Marina must have some spare ones

Tinline roll includes 8 in Form 1 and 3 in Standard 1

30th October 1931 Letter to Miss A M Roche Pelorus Bridge School Please release five surplus desks for Tinline School The Board has written to the teacher asking her to make arrangements for the transport of the desks

Please let me know sizes sent for our records . From Architect Wellington Education Board 20th October Letter to Miss D N Shepherd Teacher Tinline School telling her desks to come from Pelorus Bridge

9th November 1951 letter from D N Shepherd which she believed were to be collected that day. Didn't know size of desks But each were 2 foot 1 inch to 2 foot 2 inches in height

13th November Letter to Miss Sherd from architect thanking her for the trouble she had taken 26th May 1933 Letter from Secretary School Committee Tinline to Wellington Education Board included

- a) There was a clock supplied to our school some years ago and is now beyond repair through falling off the Mantelpiece onto the concrete hearth
- b) So will the Board supply us with a new one or will the Committee have to buy out of funds
- c) Trusting to hear from you soon R A Coleman

29th June 1933 Letter to Wellington Education Board asking to supply 1 blackboard and easel as there is only one in the school and teacher wants another one

30th July 1933 Wellington Education Board don't supply clocks any more but they will purchase one in Wellington ten inches in diameter with glass front for the sum of 30 shillings 4th July 1933 Architect of Wellington Education Board asks Mr. Coleman how much Hyloplate is in the school other than the blackboard and easel. I have to advise that only 1 blackboard and easel are supplied to Sole Teacher schools unless the circumstances are unusual

31st July Mr. Coleman replied stating there is 18 foot x 3 foot in the school it round the walls but the teacher says there are more infants in the school than he has space to set out their work

Handwritten note Mr. Caskill, what do you suggest?

28th August 1931. Letter from Wellington Education Board saying that the Inspector will be visiting in early September and they will await his report

9th September 1933 Of a Wellington Education Board inventory list these were all that Tinline Valley had. I Head Teacher, 1 built in cupboard, 2 portable cuboids, 1 ordinary chair

1 Easel, 1 portable Hyloplate and a few desks Signed by W J Scott

Then a reply including Board says they have 15 desks. Mr. Scott says 10 which is a difference of 5

30th November 1933 Mr. W J Scott writes to Wellington Education Board and includes

- a) The 10 desks are the ones in use. There are 3 more not in use but fit to use if necessary.
- b) Of the other two desks I can find only pieces
- c) The Board has not been seen since I took charge here
- d) The children state it was used in the playground for various purposes but it certainly has not been seen since I came to the school

31st July 1934. Letter from Mr. Coleman to Board (*Paper been wet*) The teacher discussed the matter of a blackboard with the inspector who promised to see about it but nothing has been done

20th October 1934 Reply from Wellington Education Board The Inspector will visit in October would the Head Teacher please bring the matter to his notice then

10th November 1934 letter from Board asking Mr. Scott whether or not a 6 foot x 3 foot piece of Hyloplate will suit your requirements Could you fix it on the wall or wherever is required

15th November Mr. Scott writes to Wellington Education Board I shall be pleased to fix to wall the piece of Board you mentioned

20th November Letter to Mr. Scott from Wellington Education Board

- a) That a piece of Hyloplate 6 foot x 3 foot will be supplied to you shortly
- b) What is the best way the material can be sent?
- c) Should it be dispatched from Blenheim and from there conveyed to Tinline Valley by Carrier
- d) An early reply appreciated



- > The school was built on Mr. Lee Hunter's property midway between the two pairs of sawmills. It was just another sawmill shack type school with primitive sanitary arrangements
- ➤ When a pair of sawmills closed down the school moved up the valley to Scott's property. The new school similar tin type was built about 2 chains (About 42 metres) from the second pair of sawmills
- > 1920-1923 Miss Rita Harford. Temporary Misses Fisk and Wills
- > February 1924 Mr. S Fee
- November 1925 Mr. G M Slater
- ➤ From February to June 1927 the following teachers taught Elsie Geddes, Harry Haig, Mrs. I B Carr. Mrs R Robertson, Allison John Lambert
- ➤ The school then closed and reopened on July 3rd with Miss V J Cook who was succeeded by Mr. C C Bradshaw who remained until February 1931 when Miss E S Giddy took over.

The site in the Upper Valley was specially chosen by the commissioner of lands in Blenheim as being the most suitable. The other is too close to Carluke

- 4th June 1913 A survey party is now engaged ill preparing for subdivision an area of something over 3100 acres of Crown land in the Opouri Valley, Marlborough, Sounds district, the forest of which has been absorbed by the milling industry. It is country of the dairying class, and it is anticipated that it will provide sections tor eight or ten settlers. The sections will probably be disposed of next season. Beyond this area there is still u considerable extent of forest country in this locality that will be brought into the domain of settlement as it is worked out by the sawmills, and the prospects are that in the near future the Opouri Valley will be an extensive scene of farming prosperity.
- 10th June 1913 Opouri Valley, Miss Doris E. Spittal; (relieving teacher provisionally)
- 9th June 1915 In reply to representations made by Mr J. S. Storey in behalf of the Education Board, the Commissioner of Crown Lands stated at the meeting of the Land Board to-day that the work of surveying the Opouri Valley school site would be commenced at once.
- 13th August 1914 Applications are invited by the Marlborough Education Board for teachers for Opouri Valley, Te Awaite, and Ronga Valley.
- 22nd February Opouri Valley— Sole Teacher, £110- £140, plus £20 housing allowance E. S. HYLTON, Secretary Marlborough Education Board

- 10th August 1915 In reference to the school at Opouri Valley, the Marlborough Timber Company offered to lease the school at a nominal rental, so that the Board could take over the control of the school. The Department undertook to rent buildings, it was decided that steps be taken temporarily to rent the building

- 2nd April 1918 During the high winds which prevailed on the 19th of last month the Opouri Valley school and teacher's cottage had a narrow escape from being smashed. The school had just been dismissed for the lunch hour, and the teacher was busy in the cottage setting a fire, when, without the least warning, a great birch tree of 13 foot girth came down, just missing

the cottage and striking' the end of the school, but owing to the rottenness of the top the damage was slight. Fortunately all the children had left the buildings and grounds, otherwise things might have been more serious

- It is said that the Marlborough timber company ran a school as the community as completely cut off
- ➤ The school was opened (as a state school) in December 1911. Miss Margaret Mary Harris of Kenepuru Sounds was the first teacher who had taught at Clova Bay school in 1910
- > She had just finished her schooling at Marlborough High School (See above)
- > 12th April 1915 Miss Celia Gould took over teaching.(*Miss Harris went to Sea View in the Awatere area then went to Endeavour Inlet School*)
- > The Marlborough Timber Company offered to let the Marlborough Education Board take over the school. Bout the Board would only take it over if they owned the land. In the end they leased the school. The Board agreed to lease the school, appoint the teachers and examine the scholars
- Mr. Miller Green, took over teaching. His father was Head Teacher of Renwick School from 1923. Mr. Miller Green lost his life in the Pelorus River. He had only been teaching a few months
- Herbert Walter Watson was the next teacher. He got to Opouri by taking Gibb's Bus from Renwick to Havelock and then by Mail Launch to Nydia Bay where he was met by Craig's timber hauler
- > Mr. Watson recalled "As he assisted me to transfer my luggage from launch to hauler he said, "why don't you store half your baggage in the Boss's Office? Don't you know teacher's don't stay long at Craig's school/ It's too lonely for you townies.
- > Said H W W "I'm different I'll stick it out, don't you worry, put them on"
- Away they went up 1200 feet up the hillside. Turning the hauler dragged them along what was once a goat and wild pig track for about a mile. Turning again. They descended about 1000 feet to arrive at the Junction of Craig's mill
- The school was situated opposite the Boarding House run by Mr. Bob Spittal He was also the butcher, the baker and the candlestick maker. In his younger days he had served in wind-jammers. He was a good photographer

- > Above all he was a very strong man and loved a good bout of Fisticuffs. Bob Spittal and H.W.W. soon became pals
- > The school was one roomed building. It was matchlined inside but unpainted inside and out. Had it been given a couple of coats of paint t would have been quite attractive.
- > The teacher's cottage consisted of two rooms was next door. There was a community hall containing a library of well selected books. There was a well-appointed billiard saloon in which the worker's won or lost their month's wages playing snooker and pool
- ➤ In a week's time I had tamed the bullies amongst the boys and inspires confidence among the timid girls
- > Their progress was rapid.

2nd July 1915 Great improvements in the social conditions have taken place m the "Opouri" during the past few months, the increase in the married population having largely contributed to this very desirable result. A very successful dance in aid of the school fund was held on the 19th inst., about twenty couples taking part. Mr. T, Williams, the secretary of the school committee, acted as M.C. The married ladies, and the school teacher, Miss Gould, had charge of the catering, which was excellently managed, and the music was supplied by the mill orchestra. The whole affair proved an unqualified success, and a very fair sum was added to the school fund.

16th July 1915 News was received in Canvastown last week that Mr. Herbert Stratford, formerly schoolmaster here, and lately of Inglewood, has enlisted for active service. Mr. John H. Walls, who was in charge of the school here for a time has also volunteered.

13th August 1915 OPOURI SCHOOL In reference to the school at Opouri Valley, the Marlborough Timber Company offered to lease the school at a nominal rental, so that the Board could take over the control of the school. It was pointed out by the secretary that the Department would not consent to equip the school unless the land and buildings were vested in the Board. The Department undertook to rent buildings. It was decided that steps be taken temporarily to rent the building

23rd March 1917 The settlers in the Opouri are applying for a school to be built, there. There are 15 children of school age at present

27th March 1917 Mr. and Mrs. Finlayson leave here on Friday 23rd March. They intend spending a short time in New Plymouth before Mr. Finlayson proceeds to camp on the 10th April. Their departure will be a distinct loss to the district. Mr. Finlayson, as head master of the local school, enjoyed the full confidence of the parents, and both he and Mrs. Finlayson were keen members of the local Patriotic Society and the Literary and Debating Society, Mr. Finlayson having occupied the position of President of the latter. They take with them the best wishes of their many friends locally, who sincerely regret their departure.

7th December 1917 Pelorus Road Board UPPER OPOURI SCHOOL. The secretary of the Wellington Education Board wrote regretting that the erection of bridges in the Upper Opouri had been deferred. The letter stated that Mr. Wells, representative of the settlers, had been written to, and informed that the Education Board was willing to provide material for the school on the lines suggested, but the Board is now informed that the settlers are net in a position at the present time to find the timber and labour to build the school.

Mr. Nees stated that the settlers had not shelved the matter, but at present were busy milking, etc.

14th November 1911 NEW SCHOOL WANTED. Seven settlers from Pelorus Bridge wrote asking that a school' building be established there without delay. At present Mr Gardiner at great inconvenience had allowed the use of a room in his house, where the children have assembled since August 1st, 1911. An outbreak of measles made some difference in the attendance, and so the average suffered. A new sawmill had lately been built in the vicinity and would shortly commence operations. Appended were names and ages of 23 children of all ages in the locality, who would at some time or other attend school. Of the 23 children 14 were five years or upwards. Mr Fulton said that the school was badly wanted. Ten acres had been granted by the Land Board, and he (Mr Fulton) had asked the Land Board to go on with, the survey as: soon as possible. It was agreed to ask the Land Board to push, on the matter of a site, and also to apply for a grant for a school.

1st June 1912 MARLBOROUGH EDUCATION BOARD. TENDERS will be received by the undersigned up to noon on MONDAY, -June 10th, for the following works:—- New School, Upper .Weld Street, Blenheim.. New School, Deep Creek. New School, Pelorus Bridge. E. S. HYLTON, Secretary

- 11th June 1912 Erection of a school at Pelorus Bridge: Alfred G. Mills, £141 (accepted).
- 9th July 1912 A sum of £10 was granted for the clearance of the Pelorus Bridge school site.
- 13th August 1912 Yesterday Mr C. Nees signalised his first appearance as a member of the Education Board by asking for a quantity of information on various matters. He ascertained that a petition signed by ten householders was required' to enable a Committee to be formed for the Pelorus Bridge school
- 10th September 1912 Mr A. G, Mills wrote asking for an extension of time for the erection, of the Deep Creek and Pelorus Bridge schools, as the timber was very green. —It was resolved that Mr Mills be asked to have the school completed so as to be in readiness after the Christmas holidays
- 15th October 1912 PELORUS BRIDGE. In accordance with the local request, it was resolved that the erection of a school-house at Pelorus Bridge be held over till March, pending the bush "burn," A petition with the necessary number of names was received, praying for the constitution of a new school district. A resolution was passed providing for the taking of, the requisite measures for this purpose
- 12th November 1912 PELORUS BRIDGE. A new school area was established for the Pelorus Bridge School district, and the boundaries were approved. An offer from Mr Mills to erect outbuildings at this school was accepted.

10th December 1912 PELORUS BRIDGE

At, the instance of Mr Nees an additional £10 was granted to the Pelorus Bridge Committee for the clearing of the. bush off the school grounds.

15th April 1913 The secretary explained' that, owing to an unforeseen delay, the heaters for the Pelorus Bridge school had not come to hand. They would be forwarded in the near future 13th May 1913 PELORUS BRIDGE. Mr J. Bown, jnr., wrote asking for information as to the course that should be followed for the election of a Committee for the Pelorus Bridge.— It was explained that the residents would have an opportunity of electing a Committee at the second meeting of householders. A sack of grass seed for the sowing of the school ground was granted.

14th October 1913 PELORUS BRIDGE. Mr Nees reported that he visited the Pelorus Bridge School and satisfied himself that clearing to the value of £10 had been done. A small garden was fenced. He suggested that £12 be granted to fence some level ground for the scholar's horses. The chairman of the Pelorus Bridge Committee wrote applying for a grant for the fencing recommended by Mr Nees.

A sum of £12 was granted, the work to be done under the supervision of Mr Nees

17th March 1914 A sum not to exceed £3 was granted for the drainage of the Pelorus Bridge school grounds

8th January 1918 Proficiency Exam success: Amy Couper

7th August 1918 Soldiers Christmas Parcel Fund Pelorus Bridge School per Miss 16 shillings 6 pence

PELORUS BRIDGE SCHOOL.

The spirit expressed by the following letter, received by the Marlborough Women's Patriotic Executive, from the pupils of the Pelorus Bridge School will be generally applauded:—"Although we are not yet old enough to go to fight for our King and country, we wish to send a few pennies to give- the soldiers a little comfort on Christmas Day, when we are at home living in luxury, while they are out in. the danger zone. 16th May 1923 The enlargement of the present classroom at Pelorus Bridge has been approved by the Department, a Bum of £275 being granted for the purpose.

27th August 1924 A A Doak Resigned

10th November 1925 Tenders called for latrines and septic tank at Pelorus Bridge

3rd May 1929 M r D V Sutton Sole Teacher Pelorus Bridge

25th March 1931 Mr J J C Williams Sole Teacher Pelorus Bridge

1st November 1932 Miss A E Mackay Sole Teacher Pelorus Bridge

17th November 1932 Miss E V V McFadden Sole Teacher Pelorus Bridge

21st September 1937 At Rai Valley the schools affected will be those at Opouri, Pelorus Bridge, Ronga, and Carluke. Pupils at present attending the schools mentioned will be conveyed to Rai Valley School by three separate bus services, one for Pelorus Bridge, one for Opouri, and one for Ronga and Carluke. The attendance roll of the Rai Valley School will thus increase from 37 to 122. The provision of extra accommodation at Rai Valley will be

necessary, and a building programme will shortly be put into operation, the intention being to build along open-air lines as far as possible.

Undated Newspaper cutting included the following information on the Pelorus School supplied by Linden Armstrong, Havelock Museum

- ➤ The first application for a school in 1911 failed because the settlers could not guarantee an average attendance of 11
- The application Named Gertrude Eva Cheek as an experienced teacher who had attended Marlborough High School from 1904 to 1908 (She had taught at Waireka School South East of Seddon for two years with a low roll number)
- Mr. Sholto Gardener opened the school anyway with Miss Cheek teaching
- > 14th November 1911 deputation from 7 settlers visited Marlborough Education Board . They had 23 children of school age. The school site was 90 acres declared by the Marlborough Land Board and a new sawmill was soon to make a start
- Agreed G Mills tender was accepted for £141. The site was on the left after crossing over the bridge on the way to Rai Valley

Pelorus Bridge (Rai Falls)

This article is a summary of Correspondence between Wellington Education Board and Tinline School on a number of topics but mainly re lack of space. All articles below are in summary form. The originals are found at Marlborough Archives

9th September 1922 Letter from Mr. J Bown Secretary of Pelorus Bridge School Committee asking

- a) Asking for an addition to the Pelorus Bridge Schoolhouse
- b) We have 37 children on the roll and 4 or 5 more are expected when the school opens again
- c) A new sawmill is being put in our neighbourhood and we expect that several additional families will be needing the school
- d) The present school is 24 foot x 18 Foot
- e) The principal windows are on the South or shaded side that the sun cannot shine into the room
- f) All our teachers have complained of the small space and bad ventilation
- g) There is a sawmill at work about half a mile from the school, so timber can be got without great expense
- h) Classroom 360 square feet
- i) September roll 35 Average 32

Undated reply to Mr. J Bown That the architect is going to come over and will call. The numbers do not disclose at present serious overcrowding. We have indeed much less space at some other schools

You may rely on the architect looking carefully at the matter when in the district 12th October 1927 letter from Mr. Bown to Wellington Education Board included

- a) I am writing about the necessity for more space for our children
- b) The size of the room is 18 foot x 19 foot long. I was in error in my last letter in stating the dimensions were 24 feet x 18
- c) The number on the roll is now 39 there are 5 more of school age, but their parents are hesitating to send them because the room is seriously overcrowded
- d) We also require an assistant teacher
- e) The younger children have made scarcely any progress sin the last 12 months
- f) We would suggest that a piece be built on the end opposite the present fireplace, If this was done there would not much boarding as the wall is taken up with windows
- g) Another fireplace would be needed

The letter was referred to the Secretary of the Board by the works and finance Committee 14th November 1922 A part of letter written by Secretary of Wellington Education Board included

- a) That on the present numbers you require extra accommodation
- b) On you roll number of 39 on the 30th September and I understand has not increased materially since that time
- c) The highest average for one teacher is 35 children
- d) Your numbers are hardly high enough to expect a permanent appointment of an assistant and you have certainly not earnt one yet
- e) The Board cannot legally pay for an assistant until the roll averages 35 for over a year
- f) To get right down to bedrock fact would you get the teacher to fill in the form which I now enclose
- g) The teacher is to underline the children who are actually enrolled and attending

18th November 1922 A letter from Mr. McCallum MP to Secretary Wellington Education Board

- a) I have just returned from a meeting of my constituents in this school
- b) It is a small room 18 x 19 badly designed
- c) There are 39 pupils with 5 more to come if there is room for them
- d) I have never seen a room so crowded
- e) Several of the children have to sit on small boxes because her is no room for more desks to be jammed into this stifling place
- f) The room should be doubled in size at once
- g) The school should be raised so that Mr. Mills can have an assistant
- h) It is quite impossible for one teacher to teach 39 pupils properly over 6 standards and I can imagine that Mr. Mills must be nearly heartbroken in his attempt to do justice to the Board
- i) Mai I ask that I ask you to regard this as an urgent matter and assist my constituents as promptly as possible and have the school doubled in size.

26th November 1922 Letter to Mr. McCallam from Education Board included

- a) We are aware that just now the school is crowded
- b) The architect has visited and is prepared to submit a proposal immediately an official report is received from Mr. Warren (School Inspector) based on umbers Mr. Bown has this week furnished to him
- c) The numbers do not permit the Board to appoint an assistant although the room is admittedly not sufficient for the present numbers

23rd November 1922 Note form Secretary of Wellington Education Board to Mr. T F Warren Inspector included

- a) You will not from Mr. Bown's list there are 45 children of 14 (years) most of whom will presumably be going out and only 4 children of 4 to come in.
- b) Some of these may not come in as they are all from 1 mile to $3 \frac{1}{2}$ miles from the school 6th January 1923 Mr. Warren's Report included
 - a) The Board should extend the existing school room and add on another classroom
 - b) In my opinion this school will always be a Grade 2 school
 - c) The popularity of the teacher may in future raise it to Grade 3 for a year or two
 - d) But on the other hand an unpopular teacher and the loss of one or two families would easily send the roll number down to 30
 - e) The present school is too small and an addition is urgently needed
 - f) The school will not be in Grade 3 this year and another classroom will afford no relief for one teacher to teach a divided class into two rooms.
 - g) If an addition of about 8 feet is made to the school it will afford immediate relief and even if the roll goes up two teachers will be able to carry on until the grade is definitely settled
 - h) When alterations are being made the school should be turned round to conform to modern ideas in lighting etc.

18th January 1935 letter from Wellington Education Board to Department

- a) The roll is 37
- b) If the room might be suitable for a single class but not for a sole charge
- c) The school is a bush one and the original design while it provided for the classroom to face the road does not serve for proper lighting and corridor. The classroom faces due South
- d) (1) Remodel he lighting\
 - (2) Providing a corridor
 - (3) Alteration to roof

Estimated cost £347 plus 6 dual desks @ 50 shillings each £15

Room is 20 foot x 18 foot (6.09 metres x 5.49 Meters)

Roll 1920, 27 1921, 27. 1922, 32 Last quarter 37


The plan is open to the following criticisms

- a) The lighting is due North
- b) The existing roof span is 20 feet and why it is being replaced is not clear
- c) To obtain the proposed area the depth has to be 28 feet
- d) It is questionable if the current small porch is worth saving for the materials

12th March 1923 Howard C Mills, teacher writes to Secretary Wellington Education Board and includes

- a) I now have 38 on roll
- b) One standard 7 pupil is one of last year's proficiencies
- c) There are two more to come this year
- d) Another family is reported to be coming up to the mill here
- e) This will make a total of 42 children

- f) "Rumours" are that one or two children are coming from Flat Creek when the room is enlarged
- g) Personally I think the roll will go up



7th April 1923 Letter to Marlborough Education Board from John Bown Chairman

- a) Can you tell me when the addition is to be done
- b) The roll has gone up to 42
- c) We are expecting a family of 7 to arrive in a few days
- d) Now the weather is getting cooler the children cannot be taken outside to be taught
- e) Can you tell me if we can claim subsidy on money collected from residents for prize money 17th April Unsigned note *(Probably from Inspector)* stating I was talking today to Miss Mapp (Formerly at Pelorus Bridge) regarding the prospects of the school included
 - a) She thinks it has reached its Max and will soon decline
 - b) She mentioned four families who had "run out" of replacement children
 - c) And also stated that two families that should attend Flat Creek School were at Pelorus Bridge because their parents object on health grounds to Kingi nursing his sister and teaching school at the same time.
 - d) In these circumstances I still think the addition of 8 feet to the present building is all that is required.

17th April 1923 Letter from Department to Wellington Education Board asking for a reply to their 22nd February letter

15th April 1923. Wellington Education Board writes that it accepts amended plan by the Department 9th May 1923 Department writes to Wellington Education Board confirming new plan at a reduced cost of £275

14th June 1923 John Bown, chairman of School Committee writes to Education Board

- a) That proposed additions to school will not be sufficient owing to growing roll
- b) Average for last term was 40 and very likely to be over 46 for the next
- c) We think the present classroom should be extended to form another classroom
- d) That two entrances will be necessary as in case of alarm or fire loss of life may occur through having only one way of getting out

12th July Another long John Bown letter to Education Board

- a) Wanting 12 foot instead of 6 foot proposed as cost would not be great
- b) The present average roll is likely to keep up for another 5 or 6 years
- c) It appears that an assistant teacher has been earnt
- d) Regarding water supply: There is no pure drinking water at the school a well would not be desirable as the stagnant or swampy water would run into it.
- e) The nearest permanent and pure water would require 25 chains of pipe and would give plenty of fall to provide a sanitary tank system
- f) If the material is supplied the residents would supply the labour
- g) The owners of the land next door are willing to give permission to use their land
- h) Regarding draining school grounds About 800 feet in field drain pipes would be necessary if these are provided the residents will do the labour of digging the drains and putting in the pipes

2nd August 1923 Howard C Mills writes to Wellington Education Board In reply to your letter re transferring pupils to Flat Creek

- a) The only children who are within Mandatory having to go to Flat creek are the Bryant Boys. These boys however are living with parents on their grandfather's farm and as their father expects to build on his own farm shortly this really leaves no one who could attend Flat Creek more conveniently than Pelorus Bridge
- b) That is the required information

14th August 1923 Mr. Bown is sick with influenza and a School Committee member writes in his name writes again to Education Board

- a) The School Committee have arranged with Mr. Sholto Gardiner for the loan of his woolshed until November 1st when he will want it himself
- b) The School Committee want to shift all the school furniture and fittings before the holidays owing to pressing farm duties caused by their cows which are beginning to "Come In"
- c) The want to close the school a day earlier so that the teacher can arrange the furniture and fittings in the temporary building
- d) We hope the alterations will be done expeditiously as possible
- e) Per F H Mills

Reply All tender forms are going to Blenheim, if you have a local then please advise him of the process, Robertson Bros Nelson have also been advised. Tenders close 1 September

11th September 1923. Contract let to Mr. William Thompson who hopes to have work finished well before 1st November

9th October Letter from Mr. Logan Clerk of Works Another week should see it Finished. I am sending out 4 sheets of hyloplate as present blackboards are in poor shape

He is to repair the boards on the outhouses where it is rotten

The gates ae not very satisfactory but the School Committee are dealing with this

The School Committee will meet tomorrow to consider the draining of the grounds and how many field drain pipes are needed

23rd October 1923 Letter from Mr. Logan to Mr. McDougall Architect

- a) Mr. Thompson has finished the contract
- b) I shall visit and report
- c) The main lights in the school were facing South and blinds were not needed very much

- d) But now that the windows face East it will be necessary to provide blinds
- e) The old blinds were bundled together and on inspection by the builders were beyond repair
- f) I will look them over but probably they will need to be renewed

31st October 1923. Another letter from Mr. Logan to Architect

- a) Painting and repairing the outbuildings cost £15-15-0
- b) The whole of the work has been well carried out
- c) I am ordering 4 new blinds
- d) I explained to the chairman the advantage of draining thoroughly ¾ of the ground and leaving open drains near the rear and end.
- e) This would provide a good football ground but not without a great deal of labour in stumping and levelling
- f) I have therefore ordered 500 concrete 4 inch pipes each 12 inches long they will cost 37/6 a hundred and £11-7-6 the lot

15th June 1927 Cresswell and White Four months since we completed a contract and we have not been paid Is it not time we received our final payment

7th December 1931 A letter from a Mr Pike that she had heard that the school may not be open next year and could he live in the building

20th July 1936 Rai valley Women's Division Farmer's Union The following motion was passed at our meeting That the Wellington Education Board be written to asking them to consider the consolidation of the schools in the Valley's districts

27th August 1936 Letter to Mr. Bown Chairman of the Pelorus Bridge School Committee still.

- a) That the WDFU letter was received
- b) That a copy of their letter is being sent to the School Committee's concerned
- c) That the School Committee's go into the matter with the Ward members concerned
- d) That the Ward Members report to the Wellington Education Board
- e) Messrs Pike and Duckworth will be visiting in the very near future

Undated letter to Mr. Duckworth Wellington Education Board representative for Marlborough

- a) The chairman approves of you and Mr. Pike should go into the area to going into this question (Consolidation)
- b) If you can persuade the parents that consolidation is the right thing you will be rendering a service to the children
- c) It is not desirable to make the change so close to the year end

22nd September That the board approve and go into the question of consolidation. Motion agreed 23rd September 1937 to SECRETARY Wellington Education Board a petition from Pelorus Bridge included

- a) Asking for continuation of a teacher at Pelorus Bridge
- b) At a meeting 6 voted against amalgamation and 3 for
- c) Of the 3 who voted for continuation One has e children attending, One has two and the third will have one of school age next term
- d) Of the 6 who voted against continuation, four have no children of school age, all having left school, One has one child, 12 months old and the other young children under 3
- e) Thanking you in anticipation of placing this petition before the board

Think this could be gone on with immediacy

In an undated report on Marlborough Schools of the Wellington Education Board it was written that there was not enough time to consolidate Pelorus Bridge in advance of the others and a temporary teacher had been appointed

16th April 1947 Report from A Wellington Education Board Architect. That a sash had been so decayed that it had fallen to pieces. Mr. Horricks of Rai valley had phoned. I advised him to arrange to repair the sash. Mr. Horricks will fix it

17th September 1948 Electrical Engineers wanted to use the school as a base

Notes from Wellington Education Board Erected 1912, Extended 1923, Septic Tank installed 1927, Last Painted 1940

This building requires a lot of repair

When conveyance started to Rai Valley the school did not join in but continued on for a while

14th July 1911 The residents of Pelorus Valley wrote asking the Board to appoint Miss Cheek as teacher at their recently -established school. Mr. Fulton thought that the Board should take steps to- have a school erected in this place. Ha pointed out that they had a temporary building, but they wanted one of their own. Mr. Storey

supported this suggestion. It was decided to inform the applicants that as soon as there was an avenge of 12 children their request would be granted

17th November 1911 Seven settlers from Pelorus Bridge wrote asking that a school be established there without delay. At present Mr. Gardiner at great inconvenience had allowed the use of a room in his house, where the children have assembled since August, 1911. An outbreak of measles made soma difference in the attendance,- and so the average suffered, A new sawmill had lately been built in the vicinity and would shortly commence operations. Appended were names and ages of 23 children of all ages in the locality, who would at some time or other attend school. Of the 23 children 14 were five years and upwards. - Mr. Fulton said that the school was badly wanted. Ten acres had been granted by the Land Board, and he (Mr. Fulton) had asked the Land Board to go on with the survey as soon as possible, It was agreed to ask the Land Board to push on the matter -of a site, and also to apply for a grant for a school.

15th March 1912 SCHOOL SITE. With regard to the site required at the Pelorus Bridge, the Commissioner undertook to visit the locality and ascertain the wishes of the settlers

19th April 1912 Marlborough Land Board With regard to the school site near the Pelorus Bridge, the Commissioners re- ' ported as requested ,by the Board at its' 1 last meeting.—It was resolved that a site comprising approximately three acres be set aside.

19th April 1912 The Department notified that a grant had been authorised for the Pelorus Bridge School. - The architect was instructed to prepare plans and specifications

17th July 1912 GENERAL A sum of £10 was granted for the clearance of the Pelorus Bridge school site

16th August 1912 Mr. 0. Nees signalised his first appearance as a member of the Education Board by asking for a quantity of information on various matters. He ascertained that a petition signed by ten householders was required to enable a Committee to be formed for the Pelorus Bridge School

13th September 1912 NEW SCHOOLS, Mr. A: G. Mills wrote asking for an extension of time for the erection of the Deep Greek and Pelorus Bridge schools, as the timber was very green.—It was resolved that Mr. Mills be asked to have the school completed so as to be in readiness after the Christmas holidays

18th October 1912 PELORUS BRIDGE In accordance with the local request, it was resolved that the erection of a school house at Pelorus Bridge be held over till March, pending the bush "burn." A petition with the necessary number of names was received, praying for the constitution of a new school district. A resolution was passed providing for the taking of the requisite measures, for this purpose.

- 9th June 1902 A letter was received from the Chairman of the Rai Valley Committee with reference to the teachership.—It was resolved to call for applications for the filling up of the position.
- 10th June 1902 The vicar conducted service at the Rai Valley for the first time on Sunday morning last. These services will in future be held with regularity on the second Sunday in each month.
- 14th July 1902 A petition was received from a number of the householders of the Rai Valley asking that the recent election of the Committee there be declared in valid on the ground of a number of "illegalities." These, briefly, are that the Chairman challenged the candidates as to their motives in offering themselves for election that after leaving the chair saying that he had done with it and then resuming it he really occupied a self-appointed position that the voting papers were not handled properly; and that the parental qualifications of voters were disallowed.

A communication was received from a number of parents representing themselves as sending the majority of the pupils to the school stating that they were quite satisfied with the teacher.

The teacher wrote asking for the Board's reason in terminating the engagement.

All the correspondence was "received."

It was resolved to call for applications for the position of teacher at Rai Valley,

8th September 1902 Further correspondence on the frequently recurring subject of the teachership of the Rai Valley School was received. The letters were from two members of the Committee and the Chairman.

The Chairman's recommendation that Miss Healy, of Blenheim, be appointed till the end of the year was adopted.

The gem of the entertainment was the action song "Grandma"; while the solo given by Miss Doris Wilson, in the garb of a London waif, Buy a Broom was a favorite item. The proceeds, amounting to about £2 10s, go towards the purchase of school prizes

5th July 1905 The very most is being made by the teachers attending the Winter School of Instruction being held at the Borough Schools. The several sub jects opened were yesterday expanded by the various specialists, and their enthusiastic pupils—who, by the way, have come at their own expense from the remote reaches of the Sounds, and from as far as the Rai Valley and Kekerangu—were given a veritable feast of reason. The Inspector-General of Schools (Mr Hogben) will give an address on Friday upon" Mathematical Geography." It is intended by the local teachers to entertain the visiting members of the profession at a social at the close of the school. Besides the ordinary sitting yesterday, two hours additional were put in during the evening.

11th September Rai Valley a verandah was granted to Flat Creek (There was no Flat Creek School listed in Marlborough Education Board schools listed in 1905)

28th December 1905 The second children's concert (writes a correspondent) took place on December 21st at the Rai Valley school, which was prettily decorated for the occasion. The concert programme consisted of action songs, step dances, recitations, tableaux, etc. the action songs by the little mites being especially good. Master Charles Maule's song, I am a little sailor boy" deserves special mention. Miss Healy, the teacher, had worked hard to make the concert a success, and such .o undoubtedly was, as the applause which greeted each item well showed. At the conclusion of the concert the chairman of the School Committee (Mr

Wratt) presented the prizes to the children. After that function had been performed, the huge Christmas Tree was dismantled, and toys and sweets distributed, every child in the Valley receiving something. The chairman then addressed the children, and complimented Miss Healy on the great success of the evening's entertainment, calling for three cheers for that lady, which were heartily given. Refreshments were then handed round by the parents, and were greatly appreciated by all present. Supper over, all wended their way homeward, fully satisfied with their evening's enjoyment.

24th December 1906 Own Correspondent.) The Rai Valley .schoolroom was packed to over {lowing on Thursday Evening by residents of that picturesque part 'of Marlborough to witness the children's concert and distribution of was a varied one, consisting of action songs, wand drill, garland drill, recreations, and choruses. Solos were sung by Misses Doris Wilson and Nesta Eyes and Master Charlie Maule, each vocalist meeting with unstinted applause, Miss Doris Wilson's song, "Silver Bells," being the gem of the evening. The action songs by the tiny tots of the school were favourite items, especially the "Dolly's Lullaby" and I'm Mother's Little Maiden." Recitations were given by Misses Winnie Price, Amelia Mills and Doris Wilson. At the conclusion of the concert, the chairman of the School Committee (Mr Hickey) addressed the audience, and in well-chosen language referred to the good work done by Miss Healy, and of the advancement of the school. The prizes were then presented, each pupil becoming the possessor of a well-bound volume. Special prizes were given by the Committee (for attendance), Mrs Smith, senr. (good behaviour), Miss Healy (best examination results), and Mr Leov (popularity). The winners of the specials were: Nesta Eyes (good attendance), Leonard Leov (good attendance). Ivy Jones (good behaviour), Doris Wilson (best examination results), and Charlie Maule (popularity). The affair was a great success, and will, result in a substantial sum towards the children's prize fund.

Mr Brownlee was establishing a new mill there. There were already 40 men

employed, and this number would increase shortly to 80. The Commissioner had been approached for a school site, and he expected a letter would have been sent to the meeting of the Board that night. It would probably arrive before the next meeting. He moved that the Chairman wait upon the Land Board and urge that a school site in the Rimu Gully be reserved from the land to be opened for selection shortly

11th June 1907 Rimu Gully Rai Valley.—Mr Russell, on behalf of Rai Valley residents, wrote concluding that the site picked for the new school was a suitable one. Not one of the Flat Creek scholars will be taken away by the new school. The settlers wished for some conclusion of the matter. There was a well defined demarcation between the proposed new school district, and the Flat Creek district

Rimu Gully school opened in 1907 for one year with Miss Elsie Storey as teacher and 22 on the roll

9th July 1907 Rai Valley.—Mr Cooper had taken .Mr Buchanan's place on, the Committee. Mr Hickey had subsequently resigned, and Mr Turner been elected. Mr Buchanan had been elected chairman

Mr Arthur Russell wrote on behalf of the settlers near Rimu Gully, Rai Valley, asking the Board to appoint a teacher, as the settlers were willing to rent a house large enough for a school.—Mr Storey reported on a visit to the locality. There was no doubt the original site for the new school was the proper one. —It was decided to fall in with the wishes of Mr Russell and the settlers.

17th July 1907 Rai Valley received 13s 3d for modelling materials

5th October 1907 During the week a set of brass instruments was purchased from the Dresden Piano Company, Wellington, for the new band recently formed in the Rai Valley, Pelorus.

7th November 1907 To the great relief of residents of the Ronga, Rai Valley Mr Lambert's plans and specifications for building a new school at Ronga have been accepted, and the work will be taken in hand at an early date. The school is much needed, for the scholars are now getting more numerous at the Ronga than at Flat Creek. At present one of Mr Brownlee's cottages, erected for one of his employees, is used as a school. *Ronga valley school started 1913 but the Carluke School started 1908 with a roll of 32 so I presume this is the school mentioned*

13th November 1907 Onamalutu. —The Committee wrote accepting Miss Healy as teacher. Miss Healy was appointed on the usual terms. Flat Creek.—The action of the Chairman and Inspector in sending Miss Black temporarily to take up Miss Healy's duties at the Rai Valley school was approved

14th January 1908 At the Education Board meeting last night a letter was read from the Rimu Gully *(Carluke)* Committee stating that there would be over 40 pupils at the new day-school there upon resuming next month. So much1 for the new timber township.

11th February 1909 Mrs Thorpe appointed

15th February 1908 Mrs Thorpe, who has been schoolmistress at Havelock Suburban for the past year, has been appointed to the Rai Valley school. Miss Richards succeeds Mrs Thorpe.

19th February 1908 t is reported that the Flat Creek bridge, Rai Valley, ,has been destroyed by fire. The report; however, lacks confirmation. It will be recollected that this bridge, a swing structure right opposite 'the Flat Creek school, was swept away by the 1904 flood and

replaced by the Government. It is also reported that the bush fire at Cullensville is raging anew.

22nd February 1908 News from Rai Valley indicates that the new swing bridge across Flat Creek was not destroyed by fire, although it became ignited several times during the passing of the flames.

22nd February 1908 With, regard to the bush fires in the Rai Valley, referred to in my last letter, I cow hear definitely that Mr J. Clifford's house was burnt, and also the residence of the schoolmistress, Miss Black, she saving her personal effects. Thus a good sum was obtained for funds for the school. Many thanks are due to Mrs Oscar Bird for her kindness in playing the accompaniments for the various items. The children all acquitted themselves in a very creditable manner. The following is the programme:—Pianoforte duet, Mrs Bird and Mrs Thorpe; action song, "Playtime," Juniors; rose dance, four junior girls; recitation, "The. News of the Day," Miss Winnie Price; emblem song, Misses Eyes, D. Jones, E. Nesbit and Master Humphrey.'Some wand drill, junior girls; quarrel polka, Gladys Erskine and Willie Price; recitation, "No Joke to be a Baby," five junior girls; singing quadrilles; /recitation, "Family of Seven," seven children; action song, "Little Bo-Peep," juniors; marching song, juniors; duet, "Where are you going to my pretty maid?" M. Climo and L. Leov; dance, four children song, "Close your dreamy eyes," Miss Doris Wilson; the sailor's hornpipe, four senior girls; song, "Tommy Atkins," Master C. Maule; recitation, "The Sick Doll," Nellie Leov and Howard Thorpe; song, "Baby's Reflections," Miss. Harriet Andrews; wand drill, senior girls; song, "Darkey Boys"; parasol song, senior girls; chorus, "Daffodils." Mr W. Barton was a capable chairman. After the concert a dance, was held, Mrs Bird, Mr Browne and, Mrs Thorpe playing the music. For some time the ladies in the district have been collecting funds for building a church, the ground being given by Mr Seymour. The church is now nearing completion, and it is proposed to open it on the first Sunday in November, when it is hoped a number of friends will be present.

11th May 1909 Mr Charles Turner, jun., Flat Creek, wrote acknowledging the receipt of the balance-sheet and letter of advice, £3 5s 9d. The letter had, however, been opened by a member of the Committee, who had retained the cheque enclosed. Mr Turner said he had applied to the person for the cheque, but his application had been met with a refusal, and the recipient had paid accounts out of the cheque that had previously been paid by Mr Turner. It was impossible for him to make out any balance sheet with such a state of affairs. He asked the Board to advise him as to what he should it' was decided to refer Mr Turner to the Post Office officials

15th June 1909 Flat Creek. —The secretary wrote complaining of the unsatisfactory condition of the school, and also asked to have the papers and cash sent to the Board by the late chairman returned. —A grant of £10 was made towards the repairs to the school, and it was

decided that a report be procured on the work.—It was also decided to fence in the school paddock, so as to enable the teacher to graze her horse there, at a cost of £4 10s

24th August 1909 Mr Strachan, Inspector of Schools, paid his annual inspection visit to the Rai Valley School last Monday, and expressed satisfaction with the work in general.

A very pleasant little dance was held in the Rai Valley School on Tuesday night.

23rd September 1909 Several pleasant dances have been held here lately, and these proved delightful to the young people. Among those present at the last one were: Mrs C. Jones, Mrs Thorpe, Mrs Hebberd, Miss Forrest, Miss Newman (Wellington), Miss Eyes, Miss Nesta Eyes, Miss Thorpe, Miss Simenon (Havelock), Miss Jennings (Nelson), Miss Bell (Nelson); Miss McMillan (Havelock Suburban), Miss Jones (2), Miss Simpson, Messrs Leonard, Campbell, Simpson, (3), Eyes (2), McKinley, Booker, Jones, Allen, Hebberd, Davies, Borck and Napier. The hall at Carluke is finished at last and is to be opened on October 1st.

38th October 1909 The school children gave a concert in the school here on Saturday night, which was a great success. The concert was held to obtain funds for prizes for the children. Among the items were several pretty little fancy dances, which the pupils did very well. Miss Gladys Erskine and Master Roy Jones were the gems of the evening, although all the children did their best. Mr Leov acted as chairman, in the absence of the chairman of the School Committee, and after the concert three cheers were given for Mrs Thorpe for the trouble she had taken.

14th December 1909 The Flat Creek School Committee wrote requesting the Board to have the school and outbuildings painted, and also to place a hyloplate blackboard on their wall inside the school and: to effect several minor improvements.

It was decided to supply the hyloplate and make a grant for the pairing, provided the estimate was favorable, the Chairman to attend to it when it came to hand. A grant of £2 for a copper for the school residence was also .made.

21st December 1909 Two pupils from Carluke and two from the-Rai Valley school sat for the sixth standard examination tit Canvastown on Friday last. One pupil from each school passed

15th February 1910 Miss Annie Healy, who was for some years teacher at Rai Valley, and' has latterly been in charge of the Onamalutu school, has resigned from' the service of the Marlborough Education Board to take up the position; of assistant at Kaiwaiwai, (Kaiwaiwai is on the Featherston Martinborough Road, The researcher's ancestors were on the School Committee about this time) under the Wellington Board. Miss Healy has an excellent record, and will be greatly missed by the scholars at Onamalutu.

14th April 1910 Mr Spear will be greatly missed from the Rai. Many of the children in the Rai have whooping-cough, and are unable to attend school

26th April 1910 Rai Valley had 91% attendance rate. One out of the 26 schools to achieve over 90%. 21 schools had less than 90%

The School Committee is as follows: —Messrs D. Couper, C. Jones, C. Leov, W. Gardiner, and A. Hebberd (chairman)

10h May 1910 The Flat Creek School Committee applied for a grant of £25 for repairs to the school. It was decided that an application be made to the Education Department for a grant for this work.

12th May 1910 The Rai Valley school was closed yesterday out of respect to the late King's memory.

On Friday evening a ball was held in the new social hall to celebrate the opening. The building was "purchased from Messrs Robertson Bros., and comprises a large dancing room, with supper-room and dressing-room attached. The floor was in splendid order, and good music was supplied by Mr Rutland on a piano kindly lent by Mrs Thorpe, for which the committee express their thanks.

14th June 1910 In accordance with Inspector Strachan's recommendations, the Board decided to extend the Rai Valley School as required by the Committee, and that the Department be applied to for a grant for this work.

28th July 1910 The Rai school is to be examined on August 4th, and I hope that the children will do their very best and do credit to their teacher. Such bad weather lately has affected the attendance at school a great deal, and will probably affect the children in their work at the examination.

14th February 1911 The Chairman of the Flat Creek School Committee wrote forwarding a list of a number of alterations recommended by Inspector Strachan. to ,be done to the school, and he asked that the Inspector's recommendation be given effect to. Mr White said that he had a good look at this school, and it was perfectly obvious that it was unsatisfactory. He thought that if the Board .could not see its way to erect a new school, which was most desirable, the -present building should be repaired. He thought the Board had no right to make young children sit in this room in the winter months when a southeaster was blowing and expect them to gain knowledge. It meant that it was more like making bacon of the children than making scholars of them. He thought the building should he widened at the back. The Chairman moved that estimates be obtained .of .the cost (1) of widening the building; (2) of the .-erection of a new school. Mr Fulton seconded the motion, which was -carried

9th May 1911 The Flat Creek Committee applied for a grant of £4 10s, to be spent on 1 the outbuildings.—Granted

13th June 1911 It was decided to call for tenders for the erection .of a new school at Flat Creek.

15th August 1911 The tender of Messrs "Ward and Sons was accepted for, alterations to the Flat Creek school.

13th February 1912 The re-papering of the school residence at Rai Valley was authorised 22nd April 1912 Rai Valley school opened last year 426 half days out of the expected 420. Good general writing at Rai Valley. About a dozen pupils at Rai Valley correspond with the Victoria League, England

The best schools were: Marshlands-, Springlands, Renwick, Clova. Bay, Grovetown, .Rai Valley.

11th May 1912 WEDDING BELLS. On Thursday, 25th April, a "Kitchen evening," and social was given by the people of the valley to Miss Dorothy Thorpe, on the eve of her marriage The kitchen utensils were varied and useful, and much fun was provided at the opening of the parcels. Dancing was then enjoyed by .the great number of people present, the music being played by Mr Rutland, of Canvastown, and the piano lent by Mrs James Jones. The hall was tastefully decorated, adding much to the pleasure of the social, while- the floor was in excellent order, Visitors were present from Carluke, Canvastown, and Deep Creek.. Previously to supper Mr C. Bryant, in behalf of the residents of the Valley, presented Miss Thorpe with a handsome clock and silver cake basket. The clock had a silver plate, bearing, the inscription: "To Miss Thorpe, from Rai Valley residents, in appreciation of her services as postmistress at Flat Creek, April 25th, 1912. The recipient, who was quite taken by surprise, replied in a happy little speech, thanking everyone for their girls. A dainty supper was then handed round, and enjoyed by all present, after which dancing was renewed. During the evening three cheers were given for Miss Thorpe, and three more for Mr Eyes, and the company sang. "For they are Jolly Good Fellows." Three cheers were also given for the ladies who had arranged the social in such an able manner. The company dispersed at. about 2 a.m.

On Tuesday, April 30th, Mr H. W. Eyes, eldest son of Mr Septimus Eyes, of Levin, was; married to Miss Dorothy Thorpe., only daughter of Miss Thorpe, of Rai Valley. The ceremony was performed -at St., Mark's Church by the ;Rev E. A. Parker: The church had been tastefully .decorated by friends of the young couple. The bride, who was given. away by her mother wore a dainty white silk dress, trimmed with silk fringe and lace, and wore a wreath and veil, and carried a shower bouquet. The bridesmaid was Miss Gladys Thorpe, of Nelson, who .wore a dainty crème one-piece dress, and wore als00o a Juliet cap, and she also carried a shower bouquet- The bouquets were the gift of Mrs G. Thorpe, of Nelson. After the-ceremony a small reception was. held at the residence of the bride's mother, to a few relatives of the bride and. bridegroom. The happy. couple left during the afternoon to spend their honeymoon in Blenheim and Picton. The newly .married couple were the recipients of many valuable and useful presents.

- 22nd April 1912 and the schoolrooms at Marama and Flat Creek were enlarged 30th April 1912 School Committee Flat Creek: Messrs C. S. Leov, W. J. Gardiner, H. W. Price, B. N. Tomlinson, and A. W. Hebberd (chairman and secretary)
- 15th October 1915 The correspondent at Flat Creek wrote representing the necessity for the attachment of two new rooms to the school-house.—It was resolved to apply to the Government for a grant.
- 12th November 1912 FLAT CREEK. The teacher wrote suggesting a plan for the renovation of the schoolhouse.—Mr Nees was asked to report at next meeting.
- 10th December 1912 FLAT CREEK. Mr Nees reported on the question of remodelling the Flat Creek school residence... He recommended that three new rooms and a, verandah be

added, The suggestions were approved, and the architect was instructed to visit the place, prepare plans, and submit them to the Government.

Libraries have increased both in number and in size, Nopera Bay, Nydia Bay, Ward, Grassmere Fairhall, Flat Creek, Ocean Bay, and St. Mary's leading in this respect and as a rule the schools when ground is being broken in this direction give one the impression that the pupils possess a quicker and more lively intelligence.

18th April 1913 The senior pupils of Blenheim Borough School again produced an operetta in creditable fashion. St. Lawrence, Koromiko, Nydia Bay, Picton, Flat Creek, and the Convent schools deserve commendation.

The school had been broken into, and sundry articles were strewn over the floor. Also, on the walls of the building in the school grounds were indecent sketches and remarks written with charcoal. The key of the school was

hidden, the teacher and scholars being unable to gain admittance until after 10 a.m. It would be well for the suspected intruder to exercise caution in future.

Maule, and had no relatives in this country. Originally he came from England, and was a teacher in the North Island before coming to Marlborough

16th October 1918 Mr Alexander Maule, of Flat Creek has received a cable stating that 58753 Pvt. W. R. Forbes, Twenty-ninth Reinforcement, New Zealand Rifle Brigade, was killed in action on September 9th Mr Forbes was formerly schoolmaster at Flat Creek, and had been in New Zealand only six months when he was called up.

9th October 1919 Wellington Education Board meeting Works authorised in the Marlborough ward included installation of electric light at Havelock school residence, a new pump for Flat Creek, and at the latter place it was decided to get expert advice on the matter of a protective groyne for the school ground, which is threatened with serious erosion.

30th January 1919 Works in the Marlborough Ward wore authorised at Flat Creek, new groyne to stop erosion

24th May 1919 Works were authorised in the Marlborough ward: Canvastown, repairs to residence; Grovetown, new drainage, etc. Okaramio. tank to replace present water supply, and estimates to be prepared for fresh system of supply at Flat Creek, in time for next meeting.

14th December 1894 Rai Valley.—Miss A. Smith notified her resignation as teacher. 16th August 1895 Rai Valley.—Mr.. E. Forrest wrote applying for the usual capitation in the case of an aided school.— Granted.

16th November 1900 Rai Valley.—Mr. R. Forrest wrote supporting a petition from Rai Valley asking the Board to establish a school at Flat Creek.

The Inspector reported upon the application, and recommended it to favourable consideration. A letter from Mr. Arthur Turner opposed the change. It was suggested that Brownlee's bridge might be planked so as to allow the children to cross the river in safety and Mr. McCallum, who is visiting Havelock, was deputed to wait on Mr. Brownlee to ask his consent to the arrangement.

14th December 1900 Rai Valley.—Correspondence with respect to the establishment of a school at Rai Valley was received, from Messrs.. Leov, Price, R. Forrest and W. Seymour, who favoured the site recommended by the Inspector. Mr. McCallum reported his interview with Mr. Brownlee at Havelock on the question of the erection of a bridge across the Rai river. On the motion of Mr. McCallum, it was resolved that the school be erected on the reserve, as recommended by the Inspector, and that Mr. Forrest, the correspondent, be informed that his offer to take the work in hand for the sum of £40 on behalf of the settlers be accepted.

14th June 1901 A letter with regard to the new school at Rai Valley was received from the correspondent.—The Secretary was instructed to request Mrs. Anderson to open the school on the 1st July, to give Mr. Forrest the necessary authority to procure the necessary furniture, and to thank Mr. Brownlee for a contribution of £5. The Board also thanked Mr. Forrest and other settlers for the interest they had taken in the work.

16th August 1901 Rai Valley.—The Board decided to pay the cost of a new porch for the school

16th August 1901 Flat Creek.—An application for the use of the school for religious purposes was approved by the Board, and Mr. Forrest was instructed to hand over the keys for these occasions.

14th February 1902 Education Board of the District of Marlborough. IT is hereby publicly notified the Board has constituted a new school District to be called the Rai Valley School District, the boundaries of which shall be as follows: The watershed of the Rai River and its tributaries; the eastern boundary of section 64 to the Pelorus River; thence by the said river to section 78; thence by the western boundary of the said section 73 to the watershed above-mentioned. The Statutory Meeting of Householders for the election of a School Committee will be held at a time and place to be notified hereafter. JOHN SMITH, Secretary. 13th June 1902 A letter was received from the Chairman of the Rai Valley Committee with reference to the teachership.—It 'was resolved to call for applications for the filling-up of the position.

18th July 1902 RAI VALLEY. A petition was received from a number of the householders of the Rai Valley asking that the recent election of the Committee there be declared invalid on the ground of a number of "illegalities." This-, briefly, are that the Chairman challenged the Candidates as to their motives in offering themselves for election; that after leaving the chair, saying that he had "done with it," and then resuming it, he really occupied a self-appointed position; that the voting papers were not handled properly; and that the parental qualifications of voters were disallowed.

A communication was received from a number of parents representing themselves as sending the majority of the pupils to the school, stating that they were quite satisfied with the teacher. The teacher wrote asking for the Board's reason in terminating the engagement. All the correspondence was "received." It was resolved (o call for applications for the position of teacher at Rai Valley.

22nd July 1902 MARLBOROUGH EDUCATION BOARD. TEACHER wanted for the Rai Valley School. Salary according to "Colonial Scale," at present £68 a year. Duties to commence in September. Applications for this appointment, giving age, condition, qualifications, and previous experience, will be received at this office up to FRIDAY, 8th August. JOHN SMITH, secretary. Lengthy correspondence,, was received from the teacher and the Chairman of Committee relative to the refusal of the former;, teacher to give up possession of the school, —It was resolved, that section 49 of, the Education Act, 1887, be, put into force; and that the Secretary write to the former teacher demanding that the key be delivered up to Mr. Forrest, Chairman of .the- Committee; and that a cheque be issued for the former teacher's salary up to September ,11th,

The Committee recommended the appointment of Miss; Ethel McMahon as teacher after the Christmas Holidays. It Was resolved that Miss McMahon be appointed from 1st January

9th October 1903 Rai Valley School. —Residents in the Rai Valley are delighted with the success that has attended the efforts of Miss E. C McMahon, Head Teacher of

their School. The number on the roll is 21, the average attendance for the quarter was 16, and 15 were presented for examination and 15 passed. The School was examined on 25th ult. Following are the passes:—Standard VI., Robert Forrest; Standard V., Madge Eyes, Dean Eyes; Standard IV., Gordon Rayner, Laurie Rayner; Standard 111., Evan Jones, Keith Rayner, Doris Wilson, Luigi Vannini; Standard II, Ivy Jones, Eila Nesbitt, Vida Rayner; Standard 1., Charlie Maude, Doris Jones, May Price.

- 16th October 1903 The Inspector of Schools recently made his annual examination of the local School, all pupils presented passing their respective Standards. The Committee, pleased with the result, purpose giving the children a treat, and presenting them with prizes at the Christmas holidays
- 18th December 1903 The Rai Valley Committee applied to have the school building and teachers'. cottage painted and a wafer tank supplied. —It was resolved to inform them that the painting of the buildings most await its turn, other applications to the same effect having priority.
- 15th April 1904 Miss McMahon was appointed assistant teacher at the Waitohi School. The Inspector was empowered to fill the vacancy that would be caused at Rai Valley,
- 29th April 1904 RAI The following Committeemen were elected for the ensuing year:—-A. Hewetson, D. Rainer, 0. Leov, jun., W. Jones, W. Turner. Mr. Rainer was elected Chairman,
- 10th May 1904 The annual election of the local School Committee took place last week, when Messrs. C. Leov, D. Raynor, ~W. Jones, A. Hewetson, and W. Turner were duly elected. Miss A. Healy takes up the duties of schoolteacher, the late teacher having resigned to take up a similar position at Waitohi
- 13th May 1904 Miss Healy appointed Rai Valley
- Flat Creek.—A deputation from Flat Creek (Rai) waited on Mr. Graham, M H.R., at Canvastown, with reference to the erection of a footbridge across the Rai River at Flat Creek, so that children could cross to get to school. It appears that a sum of /30 was voted by the Government for this work, and Mr. Graham promised to have the matter arranged so that the footbridge could be put up almost immediately
- 16th September 1904 The Rai Valley Committee asked for certain improvements to the ground and fences, and for the painting of the school.— Resolved to defer the matter Until the settlement of the question of purchasing the site.
- 14th October 1904 It was resolved to ask Mr. R. Forrest to obtain an estimate of the cost of surrey- of land at Rai Valley required for a school site.
- 2nd May 1905 RAI VALLEY. The following were elected:—• Messrs. Arthur Wratt, W. Jones, C. Mills, A. Hewetson, and 0. Leov. Mr. Forrest was in the chair, and only seven people attended the meeting. Mr. Wratt was subsequently elected Chairman of the Committee.
- 18th May 1906 Flat Creek—The re-building of the school chimney was referred back to the Committee, to ascertain if a man in the locality could be got to build it.
- 11th September 1906 Rai Valley Committee were granted the cost of a pump

- 11th September 1906 Inspector's Reports Rai Valley: Satisfactory; much pleased with great improvements.
- 15th March 1907 Flat Creek and Rimu Gully.—The Chairman of the Flat Creek Committee wrote urging that the projected new school at Rimu Gully be placed half a mile further away from the Flat Creek School. This would not take so many pupils away from Flat Creek School—Mr. Reader informed the Board that the site had already been chosen by the Land Board.—It was decided that Mr. Hickey be informed to this effect

to the Editor. Sir,—Hoodlumism seems (o be growing rapidly in this district, and it is to be traced to the leniency of the authorities. Since those lads were practically let off scott free a concert in the Rai has become impossible. At the school concert held recently the behaviour of certain lads was scandalous. Insulting behaviour and horse-play have been of regular occurrence at public functions. At an entertainment given by the Rev. Mr. Scott on Saturday night the same behaviour was repeated. In addition to the usual forms of annoyance Mr. Scott's pony was interfered with, which led to its being staked in two places and lamed. Is this sort of thing to go on indefinitely? When these lads appear before the Court, which won't be very long, I hope they will be taught a lesson in the shape of a month, without the option of a fine;—I am, etc. Indignant. Rai Valley.

12th April 1907 Flat Creek.—The Chairman of the Committee again wrote in reference to the projected establishment of a new school in the Ronga.-Mr. Reader reported that the site had not yet been fixed, and would probably be removed further away from Flat Creek.

17th May 1907. Flat Creek.—it was decided to postpone the question of the site of this school until after the meeting of the Land Board.

In regard to the selection of a site for the new school at Rai Valley, Mr W. Hickey, Chairman, Rai Valley School Committee, wired to the Land Board stating that Mr. Turner did not want the Mill section, and that if a school were erected on the smithy site in Rai Valley his Committee could prove that water is procurable. It was resolved to leave the selection of a site in the hands of the Commissioner, who will deal with the matter when the subdivision of land in the Rai Valley, for workmen's homes, is made. .

- 14th June 1907 Flat Creek.—Requisites for the school costing £1 15s were granted.
- 12th July 1907 Rai Valley.—Mr. Cooper had taken Mr. Buchanan's place on the Committee. Mr. Hickey had subsequently resigned, and Mr. Turner been elected. Mr. Buchanan had been elected Chairman
- 15th November 1907 Flat Creek.—The action of the Chairman and Inspector in sending Miss Black temporarily to take up Miss Healy's duties at the Rai Valley school was approved.
- 17th January 1908 Flat Creek.—The Committee recommended either Mrs. Thorpe or Miss Black for the vacant teachership.—The appointment was deferred for one month in order to give Mrs. Thorpe an opportunity of applying tor this position as well as that of Havelock Suburban.

- 14th February 1908 Appointed Rai Valley; Mrs. Thorpe.
- 21st February 1908 The teacher's residence adjoining the Plat Creek School has been totally destroyed. Fortunately Miss Black, the teacher, was able to save her personal belongings.
- 13th March 1908 Rai Valley.—It was resolved to appoint Miss Black as temporary teacher of the school.
- 17th April 1908 Rai Valley.—The Chairman asked the Board to do something towards renovating the school residence.—Mr. Reader reported on a visit to the house, and described the property as the worst and most dilapidated in the Board's possession. The Committee had estimated that £6O would put on two extra rooms, as asked for by Mrs. Thorpe, the teacher, and renovate the other portion of the building.—Mr. Storey said it was predicted that 27 children would be attending the Flat Creek (Rai Valley) school before long.—It was resolved that £60 be granted by the Board, the Town Committee to pass rough plans when submitted.
- 15th May 1908 Rai Valley.—A letter was read that the repairs to the teacher's cottage were completed, and it was now ready for the teacher's use. Accounts from Mr. Lambert for £4 and £7 for repairs and additions were passed. An estimate of £55 for further additions was submitted, and , it was agreed to grant the amount.—
- 14th August 1908 Mr. Lambert's offer for building a double chimney at the Rai School was accepted,.
- 16th October 1908 Rai Valley.—An account for desks was forwarded, and also an application for a subsidy on the cost of the work of stumping and clearing the ground.—The account was passed, and it was resolved that the subsidy be granted. 9th April 1909 The following teachers were re-appointed by the Mrs. Thorpe, sole teacher Rat Valley.
- 30th April 1909 FLAT CREEK. There were very few householders at the meeting on Monday evening, when the following were elected Messrs. C. Leov, Hibberd, Gardiner, Best and Bird. Mr. Hibberd was appointed chairman.
- 14th May 1909 Mr. Charles Turner, jun., Flat Creek, wrote stating that the Board's letter with cheque for 65 shillings 9d had been opened by a member of the committee, who had retained the cheque enclosed. Mr. Turner said he had applied to the person for the cheque, but his application had been met with a refusal, and the recipient had paid out of the cheque accounts that had previously been paid by Mr. Turner.' It was impossible for him to make out any balance sheet with such a state of affairs. It was decided to refer Mr. Turner to the Post Office officials.
- 14th May 1909 The Chairman of the Flat Creek School Committee asked that the money and papers sent in by Mr. C. Turner be returned. He also pointed out that there were only two acres of the ten acres used by the school.—It was decided to inform Mr. Hebberd that the teacher was entitled to the income from the balance.
- 18th June 1909 Flat Creek—The Committee wrote asking for certain improvements to the school.—The sum of £10 was voted towards the improvements set out in the letter. It was also agreed to vote £4 10s towards eighteen chains of fencing near the school", where the teacher could run her horse.

17th December 1909 The Flat Creek Committee were granted a blackboard and £2 towards a copper, and are to submit an estimate of the cost of painting the school.

17th June 1910 Mr. A. Johns' appointment to the Elaine Bay school was approved; it was

17th February 1911 At the Board meeting this week the chairman of the Flat Creek School Committee wrote forwarding a list of a number of alterations recommended by Inspector Strachan to be done to the school, and he asked that the Inspector's recommendation be given effect to. Mr. White said that he had a good look at this school, and it was perfectly obvious that it was unsatisfactory. He thought that if the Board could not see their way to erect a new school, which was most desirable, the present building should be repaired. He thought the Board had no right to •make young children sit in this room in the winter months when a south-easter was blowing and expect them to gain knowledge. It meant that it was more like making bacon of the children than making scholars of them. He thought the building should be widened at the back. The chairman moved that estimates be obtained of the coat (1) of widening the building; (2) of the erection of a new school. Mr. Fulton seconded the motion, which was carried. The Havelock committee were granted three lengths of hyloplate for the school walls

17th March 1911 An application was received for a new school at the, Rai Valley, or as an alternative to have the present school extended. It was decided to forward the application to the Education Department with the recommendation that the school be extended

16th May 1911 Flat Creek Committee applied for a grant of £4 10s, to be spent on the outbuildings.

16th May 1911 The Education Department wrote advising the Board that a sum of money had been granted for the enlargement of the Rai Valley School, The hope was expressed that the design of this school was one that the Board would not follow in future. It was decided to call for tenders for this work, and that Mr. H. Watson supervise the work

16th June 1911 It was resolved to invite tenders for a new school at Flat Creek

11th July 1911 TENDERS are invited up to SATURDAY, 22nd July, additions to the Rai Valley School, Flat Creek. Plan and specification may Be seen at the school, and at the office of the Board, Blenheim

15th September 1911 Several minor requisites for the Flat Creek School were granted

8th February 1912 BRIDGE REPAIRS. Mr. Leov reported on the condition of the swing bridge, over Flat Creek. This bridge was much used by school children and the decking boards were all more or less in a rotting condition. The clerk said that hitherto the bridge had been maintained by. the Roads Department, and that the Board had, so far, taken no responsibility. Mr. Storey pointed out that the conditions were somewhat different now, and moved that the Board bear half the cost of redecking the swing bridge if the work is completed within two months, the settlers to pay the balance. Carried

18th October 1912 TEACHERS' RESIDENCES The correspondent at Flat Creek wrote 1 representing the necessity for the attachment of two new rooms to the school house.—It was resolved to apply to the Government for a grant.

- 15th November 1912 The teacher wrote suggesting a plan for the renovation of the school-house. —Mr. Nees was asked to report at next meeting
- 13th December 1912 FLAT CREEK. Mr. Nees reported on the question of remodelling the Flat Creek school residence. He recommended that three new rooms and a verandah be added. The suggestions were approved, and the architect was instructed to visit the place, prepare plans, and submit them to the Government. 19th December 1911 Mr. D. A. Strachan, M.A., Inspector of School for Marlborough, conducted the annual Standard VI. examinations daring last week, and has kindly supplied the following information Proficiency Nellie Leov Competency Gladys
- 17th January 1913 FLAT CREEK. 'The members of the Board who visited Flat Creek reported as to the additions required to bring the school up-to-date. —The report was adopted, and it was decided to await a reply to the application for a Government grant.

- 13th June 1913 FLAT CREEK. The committee was granted the usual 10s in the £ subsidy on a sum of £7 collected for a school library, and a £1 for £1 subsidy for a cupboard in which to keep the books
- 8th August 1913 Pelorus Road Board A letter was received from the secretary of the Flat Creek school committee the Board if it would meet the committee half way to the extent of £5 towards turning Flat Greek stream from the top corner of school playground in more of a direct line to the bridge. Snob a course would protect the school grounds and also the approach to the north side of Flat Creek bridge. The Board recognised the importance of the work, and Mr. Bryant and the secretary were deputed to report on the matter at next meeting
- 12th September 1913 FLAT CREEK. The Board decided to grant the usual subsidy in respect to an amount of £7 raised at Flat Creek for library purposes at the school.
- 12th December 1913 The Secretary for Education notified that grants had been authorised for additions to the residence at Flat Creek. The secretary was authorised to call for tenders for the remodelling of the Flat Creek residence, and to arrange for the removal of a stump on the Flat Creek ground
- 16th January 1914 FLAT CREEK With regard to a request from the teacher that a sceptic tank be installed, it was resolved to reply that the question of providing such installations for school residences was a. policy matter the Board had not yet discussed
- 20th March 1914 TEACHER'S RESIDENCE It was resolved that tenders be invited for the erection of a teacher's residence at Flat Creek, and the Town Executive was empowered to accept a tender.
- 12th June 1914 FLAT CREEK The Committee was voted the sum of £8 2s for the reerection of a chimney. It was agreed to share with Mr. D. J. Cooper the cost of reerecting ten chains of fencing
- 12th March 1915 The application of Mr. C. Bryant to have a household school established at his residence at Flat Creek was not entertained. It was pointed out that the desired school was within a short distance of the public school at Flat Creek, and the Act would not permit of the establishment of another school in such close proximity

11th May 1915 School Committee . Flat Creek—Messrs. J. D. Couper (chairman! , 0. S. Leov, H. Price, Wilson, and W. Gardiner

17th September 1915 The Flat Creek Committee was granted a subsidy of 25s on the piano fund raised. The secretary of the Board stated that probably he could procure a £ for £ subsidy from the Government. In regard to boundary fence, it was decided that the fence be repaired, in conjunction with Mr. Hebberd

There was no doubt the original site for the new school was the proper one. —It was decided to fall in with the wishes of Mr Russell and the settlers

13th August 1907 RIMU GULLY. The Department intimated that a grant was available for the proposed new school at Rimu Gully. Mr Reader said they would need before long to accommodate forty children. He said he understood Miss Storey had been recommended for the teachership, and would be. pleased to move that she be appointed. It was resolved that a separate school district be gazetted; that the Government be thanked for the grant that the Committee suggested be appointed; that the residents be asked to submit a plan; and that the site furthest from Flat Creek school be chosen definitely.

15th October 1907 Havelock. —Mr Reid, contractor for twelve school-desks, asked where to send them.—Mr Storey reported having inspected the desks. He mentioned that Canvastown and Rimu Gully required desks.—The Secretary was instructed to send payment, and notify that the desks would soon be sent for.

11th April 1908 RIMU GULLY. BALLOT FOR SECTIONS.

Our Havelock correspondent writes: —A ballot was begun on Friday morning, under the supervision of the District Commissioner, for allotments in the Rimu Gully village settlement, which is situated about 23 miles from Havelock, close to Brownlee's new mill

14th April 1908 Mr Storey said that the Rimu Gully school was surrounded by rubbish

15th August 1908 The Education Board has received a notification from the Department of Lands and Survey that Section Block 1., Wakamarina Survey District, of rather more than five acres,- has been set apart as a school site for Rimu Gully (Carluke).

24th October 1908 LOCALITY AND DESCRIPTION. This land comprises the sawmilling area recently cut out by Messrs Robertson Bros., and is situated on the main road between Havelock and Nelson, being-distant 19 miles from Havelock and near the Rimu Gully Village Settlement (known locally as "Carluke")

Undated Newspaper cutting included the following information on the Rimu Gully School supplied by Linden Armstrong, Havelock Museum

- ➤ Early in March 1907 a move was made to start a school at Rimu Gully. Brownlee's had increased their payroll and more families had arrived
- > At an informal meeting it was announced that one if Brownlee's storage shed would become available and this could be used as a classroom.
- As soon as this became public the Flat Creek (Rai Valley) School Committee became upset
- > Letters to the land Board and Marlborough Education Board pointing out there was no need for a second school were written
- At a meeting it was announced that not one Flat Creek child would be taken for a new school
- > 9th July 1907 Mr. Russell conducted the Board asking for a teacher to be appointed as they could rent a suitable house for a school
- > Settlers were asked for a plan for a new school on Section 32 Block 1 of the Wakamarina Survey District
- ➤ Mr. J A Lambert prepared plans and contracted to build it for £140. Accommodation was provided for 54 children Mr. Lambert would provide desks at 25 shillings each (There was 20 shillings in a pound)
- > September 9th a new school district was formed for Rimu Valley
- Marlborough Education Board agree to start school in one of Brownlee's four roomed houses. This house was in the area called the Back Alley, overlooking the Carluke Domain
- ➤ The first teacher was Mrs Jack Doyle. Maiden name Elsie Storey, She had recently been relieving at Tua Marina . In July she travelled by Newman's Bus and took up living with Mrs Jack Scott. She was allocated £1 travelling money
- > January 13th 1908 The School Committee reported the new school will soon be finished
- ➤ The Board told the School Committee that Miss Storey's appointment was temporary and when finished the Board would appoint a male teacher
- > The School Committee expected 40 students on opening and wanted a male certificated teacher
- \gt 13th April 1908 the building was finished at a cost of £175. The Board also wanted to put a ring fence around to keep out wandering cattle
- > The school started with a roll of 24
- ➤ It was not until August that the Education Board found a Male Teacher to replace Miss Storey. Mr. Hugh Foley M A was an Irishman.
- He was single but during his stay he married and fathered twin boys
