Mataikona School

The following information comes from Alic Foreman long time resident of Mataikona Station and a paper by Alison Sutherland who had researched the material held at National Archives

The Mataikona School was held in the present kitchen of the shearers quarters. The owner of the station at the time was Peter Taylor whose son in law was Mr Makenzie.

The Wellington Education Board had a 2 acre site "around the corner" which was labelled the Ferryman's Reserve. Not that there ever was a ferryman.

There is evidence that there was a school at Mataikona in 1845 and 1846. There are 2 log books written in Maori held by National Archives. There were 20 children all of maori descent attending.

1945

5 children attended. Makenzie and Pavitt children

1946

Same 5 children. Teacher D M Willbond

1947

5 Children One Pavitt left and another Makenzie started

1948

The teacher is Miss K B Pavitt (Brenda) and there are now 9 children.

1949

Miss Pavitt is still teacher. 9 Children still in attendance.

The school day ran from 9 am to 3. 15 with a lunch break between 12.00 and 1,25 pm.

Carotenes and Makenzies lived a quarter of a mile from the school. Noel Karaitiana aged 14 was absent from 4th October 1948 to the end of the year because he fell into a fire and burnt his hands and face.

Mary Mackenzie (aged 12) was absent for a period in 1949, the teacher stated she would not divulge the reason in writing
